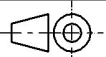

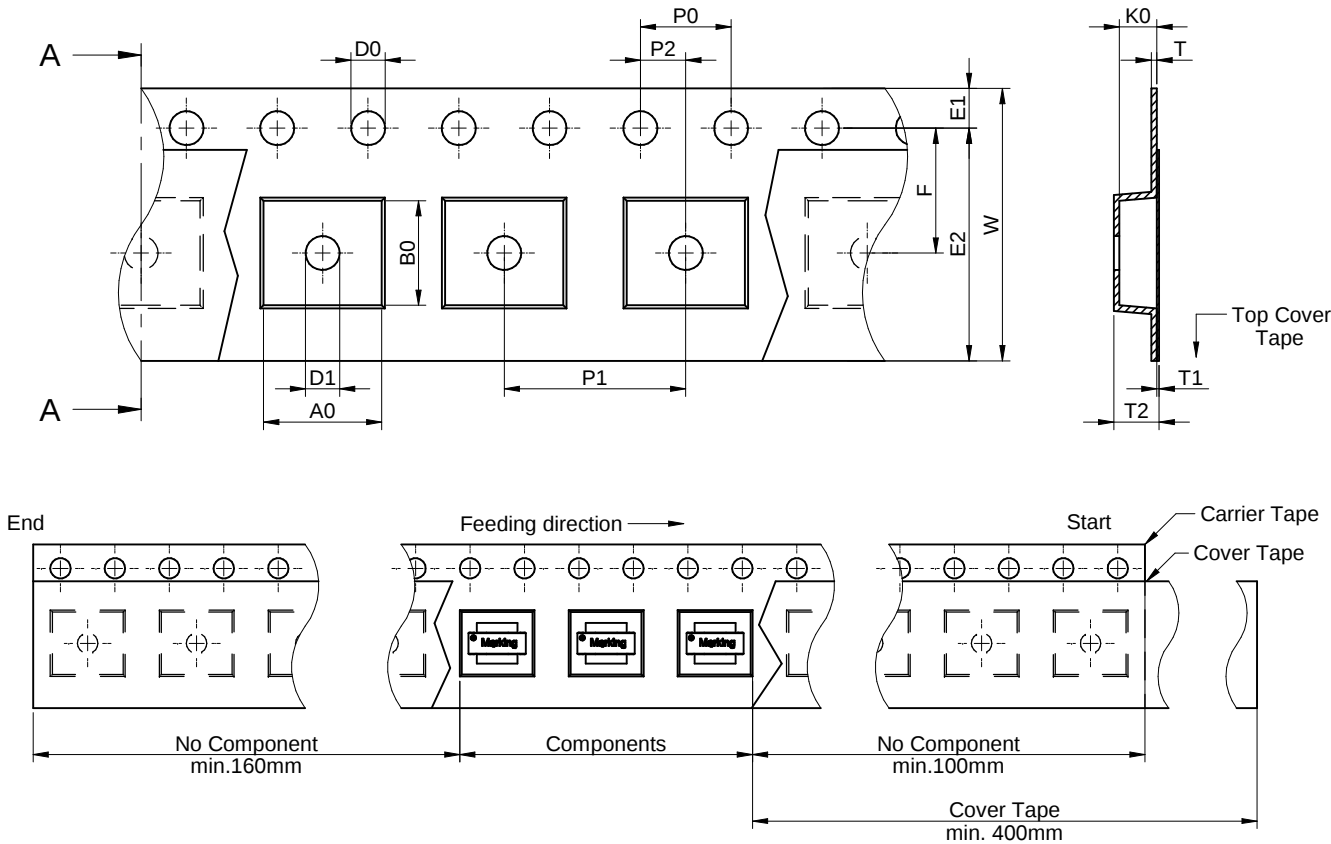
Typical Temperature Rise vs. Current Characteristics

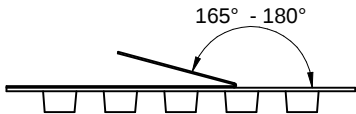

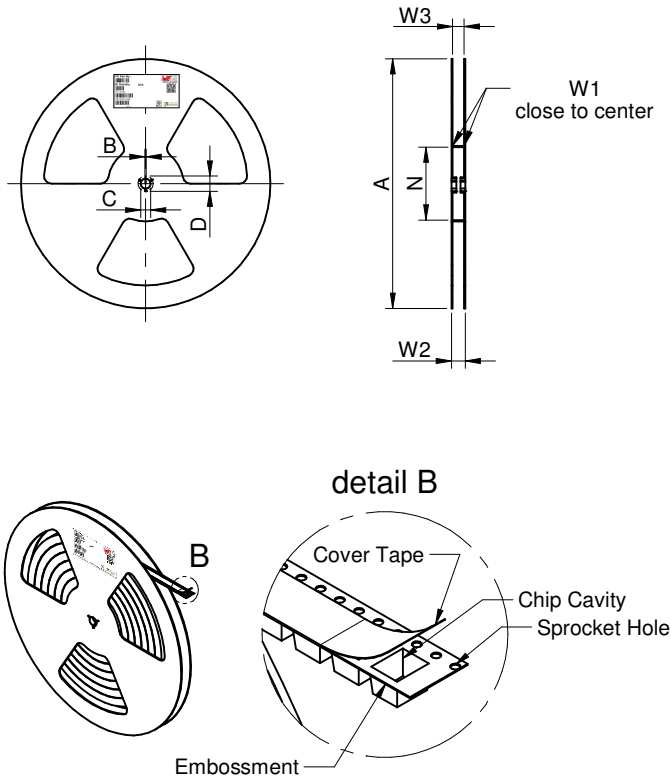

Product specific:

Soldering:

- The solder profile must comply with the technical product specifications. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

Cleaning and Washing:

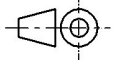
Storage Conditions:
