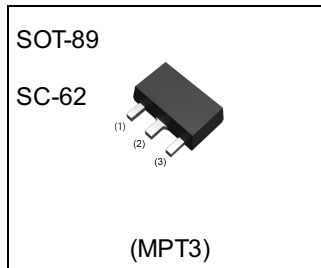

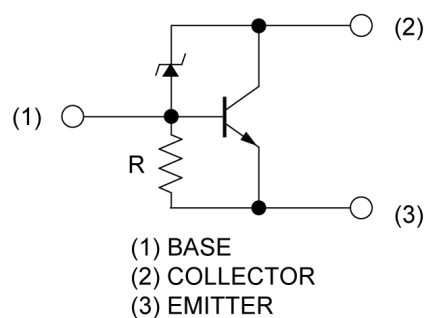

Fig.1 Ground Emitter Propagation Characteristics

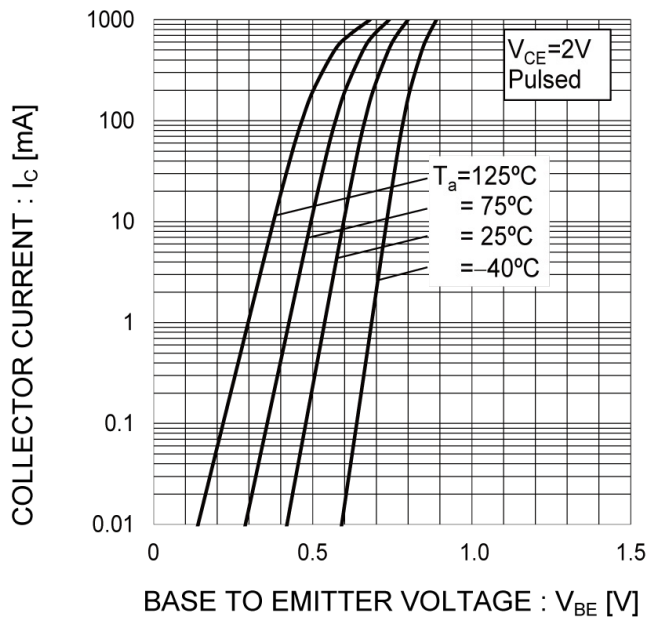


Fig.2 Typical Output Characteristics

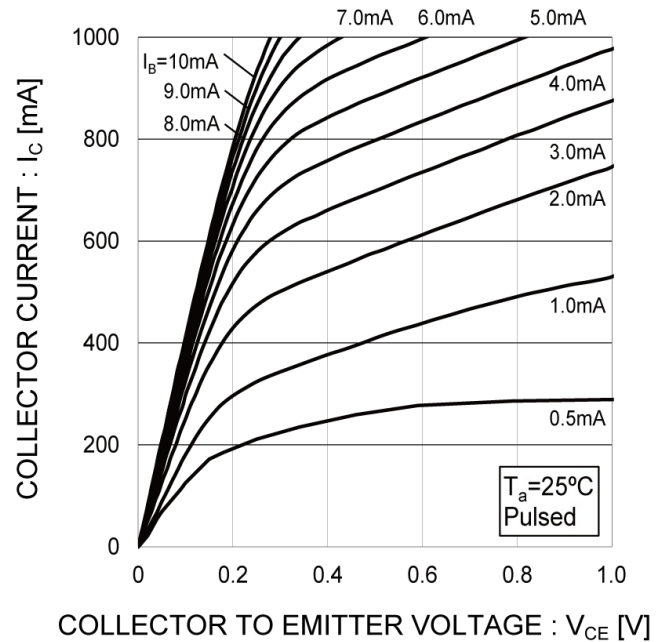


Fig.3 DC Current Gain vs. Collector Current

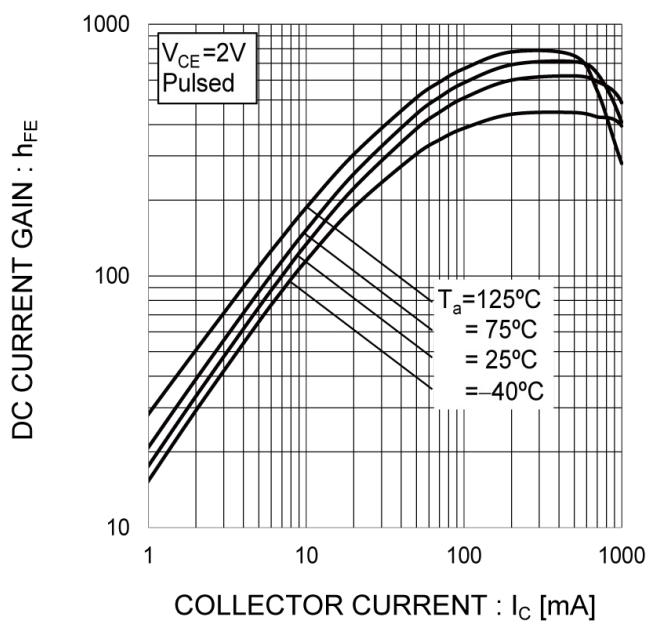
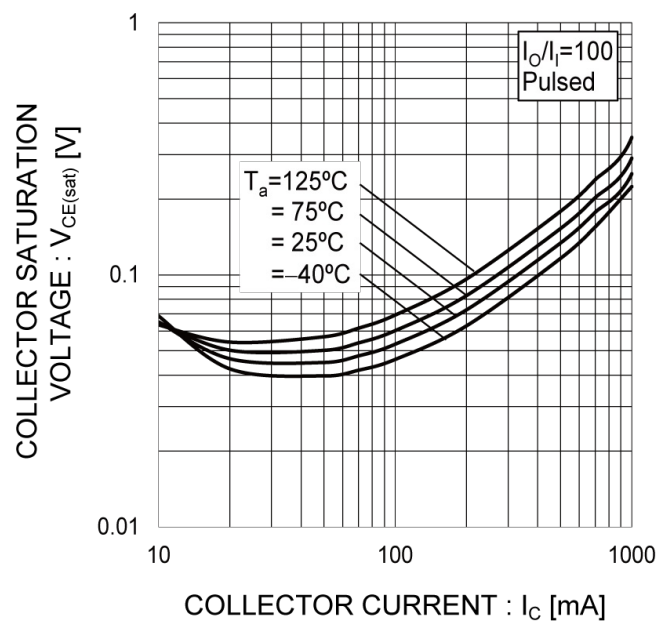


Fig.4 Collector-Emitter Saturation Voltage vs. Collector Current( $I$ )

Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current(I<sub>C</sub>)

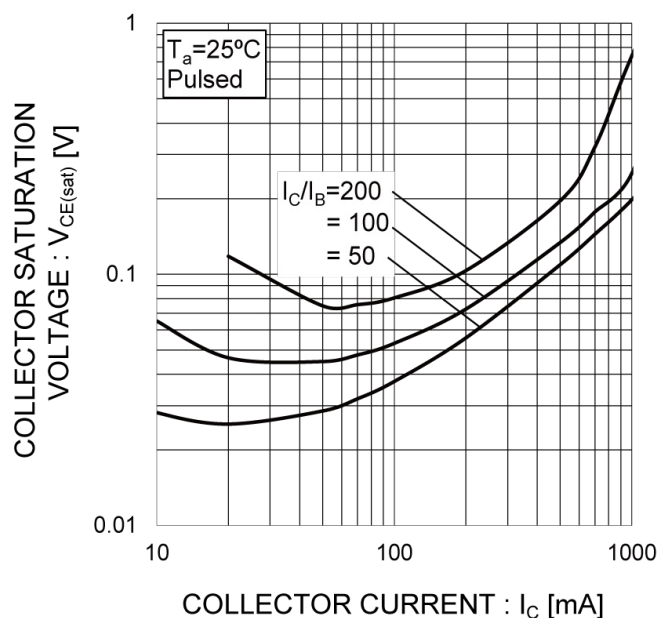
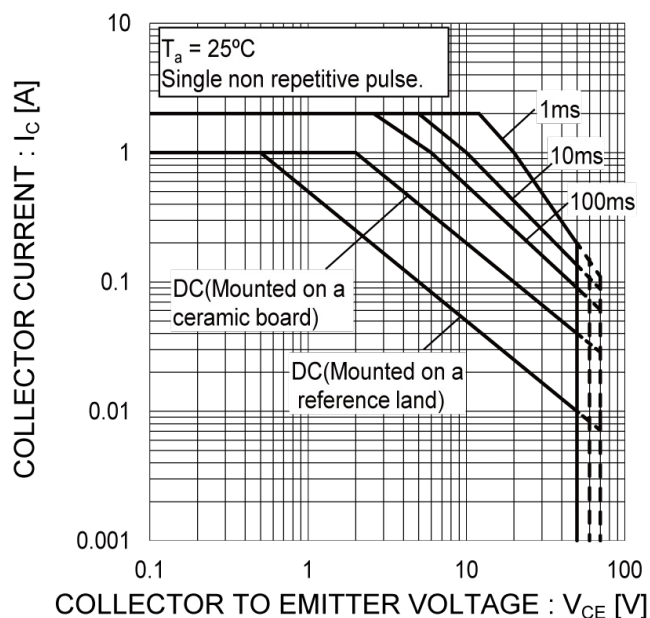


Fig.6 Safe Operating Area vs. Collector Current(I<sub>C</sub>)

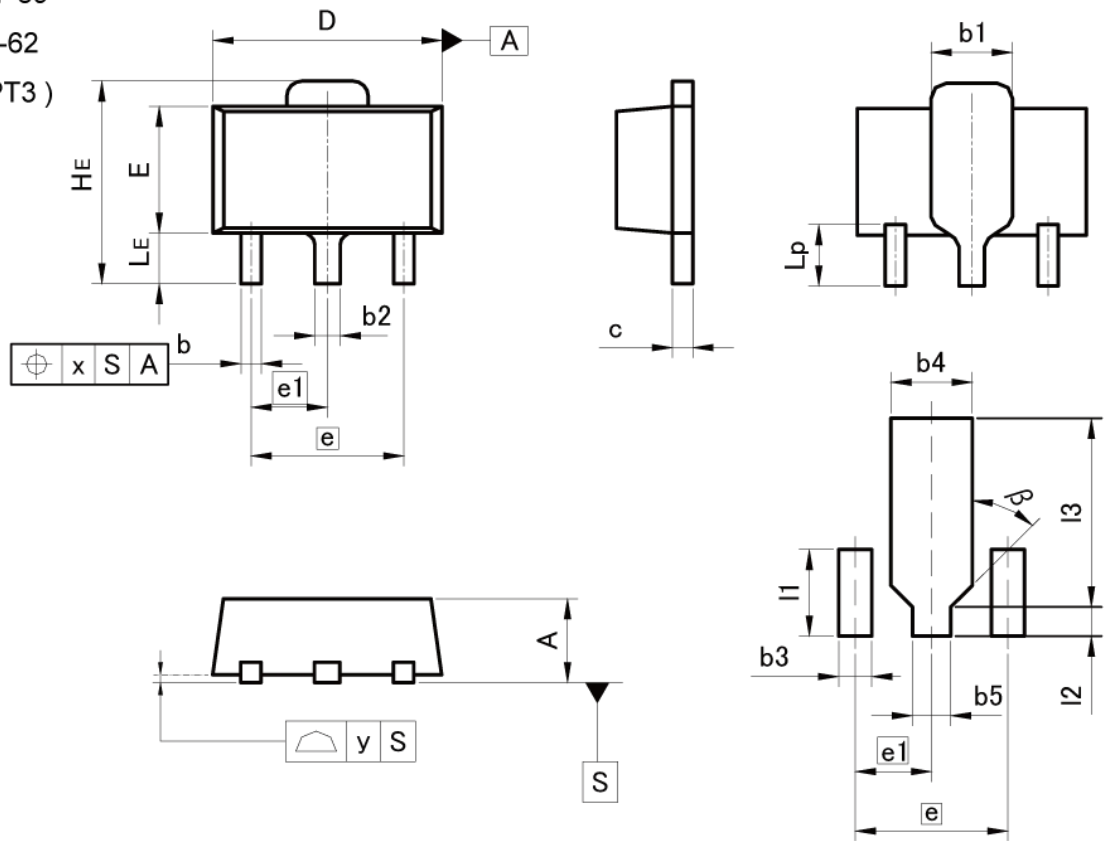
