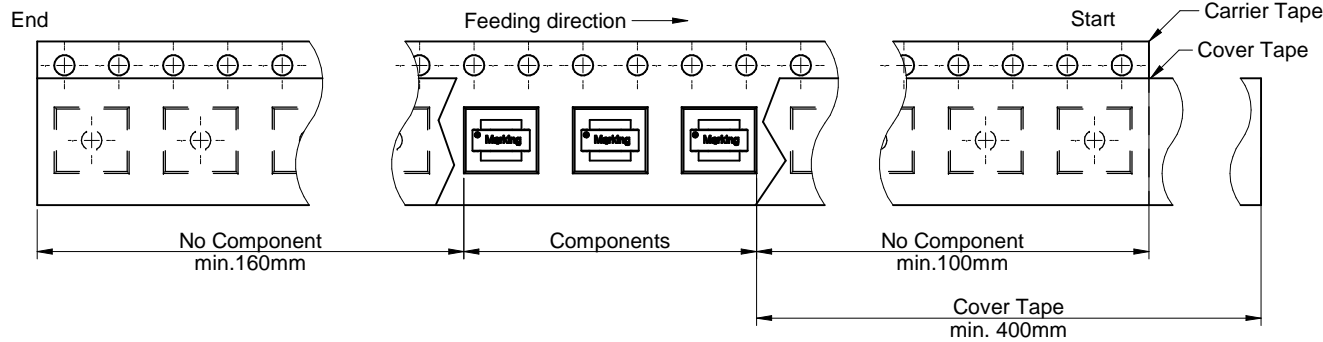

Soldering:

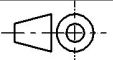


