Product specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component, marking or scratch the material. Washing agents may have a negative effect on the long-term functionality of the product.

Storage Conditions:

- A storage of Würth Elektronik products for longer than 12 months is not recommended. Within other effects, the terminals may suffer degradation, resulting in bad mounting. Therefore, all products shall be used within the period of 12 months based on the day of shipment.
- Do not expose the components to direct sunlight.

- Use a M4 screw to mount the Earthing Metal Clip to the PCB.
- The Earthing Metal Clip shall not exceed the recommended clamping torque. If the recommended clamping torque is exceeded, there is a risk that the Clip will not be able to push back into the initial state.
- Do not bend the Metal Clip to the opposite position, as the material will overstretch and possibly break.
- Avoid connecting, touching, or overlapping the contact between the cable and PCB with any non-conductive coating.


