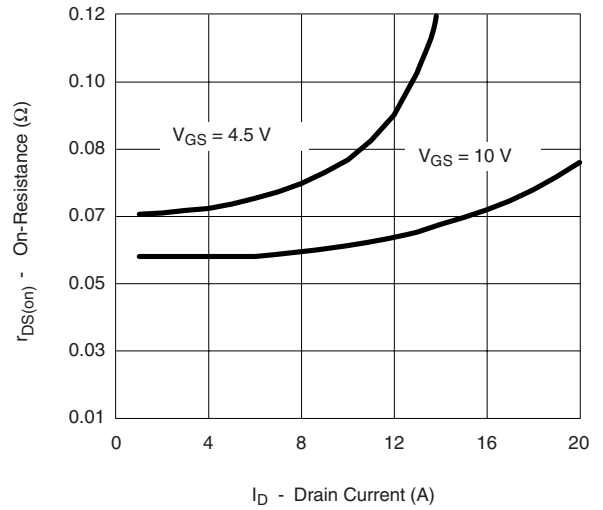

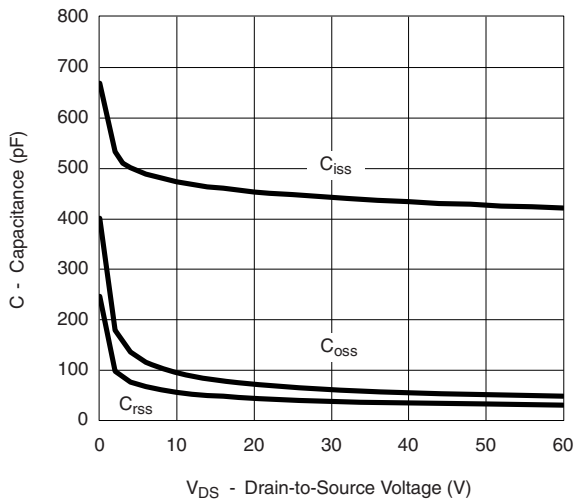

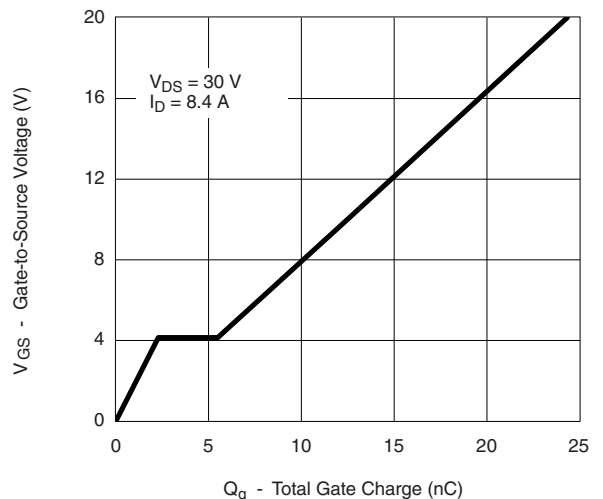
Transconductance

Capacitance

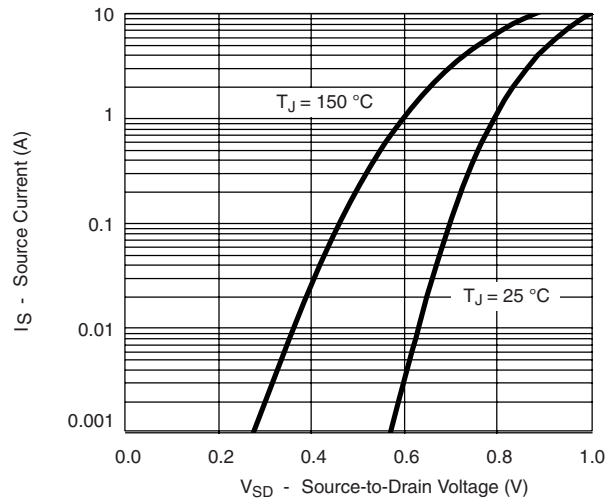


Gate Charge

On-Resistance vs. Junction Temperature

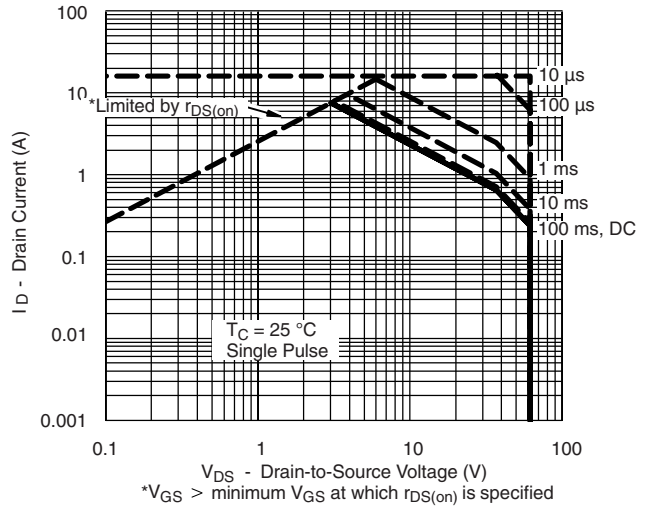


Source-Drain Diode Forward Voltage

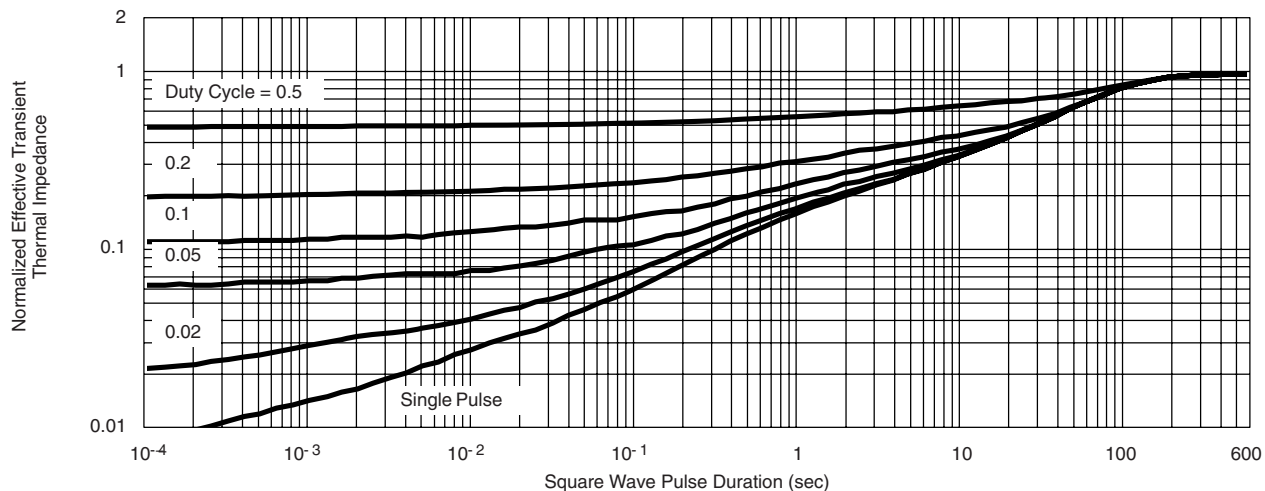


Drain Current vs. Case Temperature

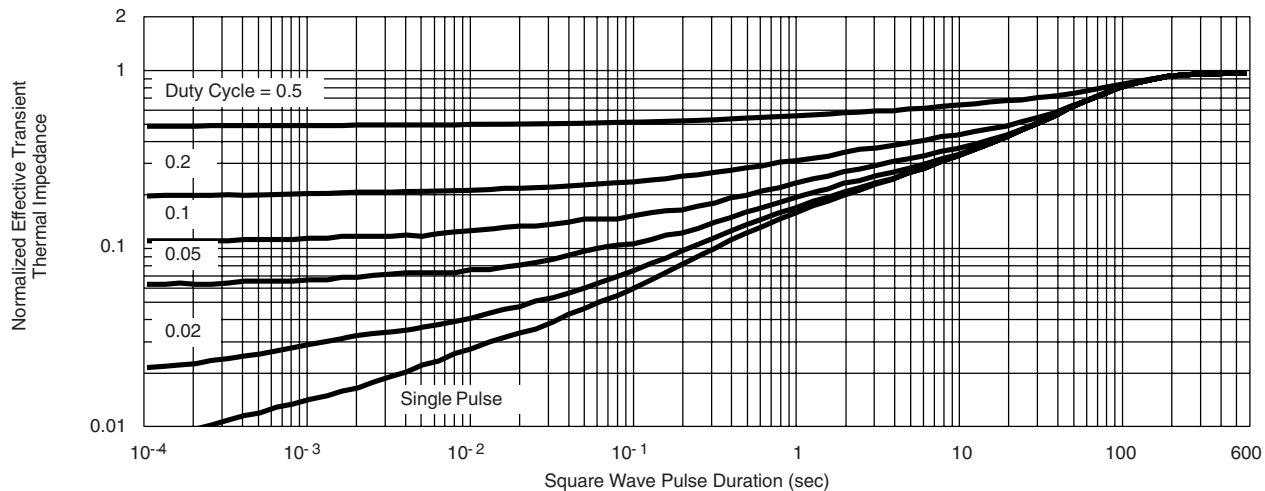

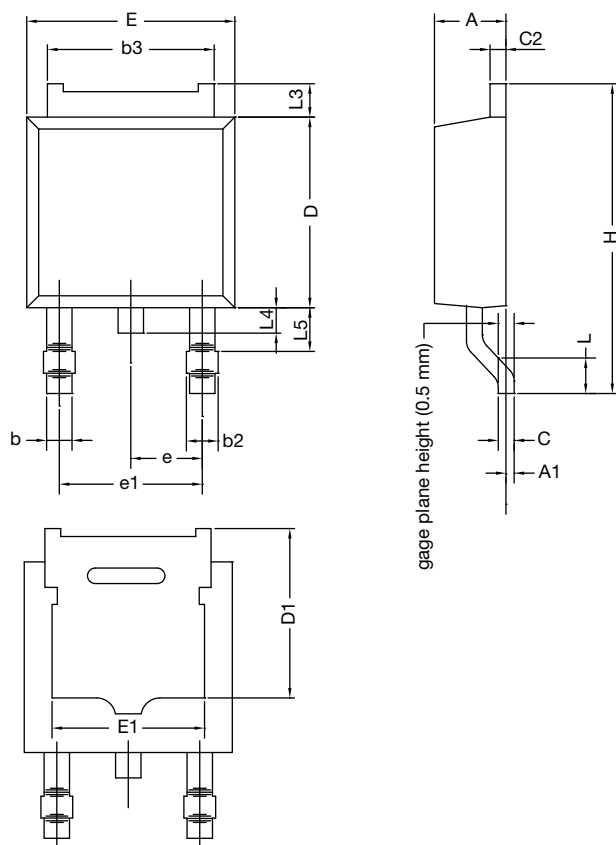


Normalized Thermal Transient Impedance, Junction-to-Ambient

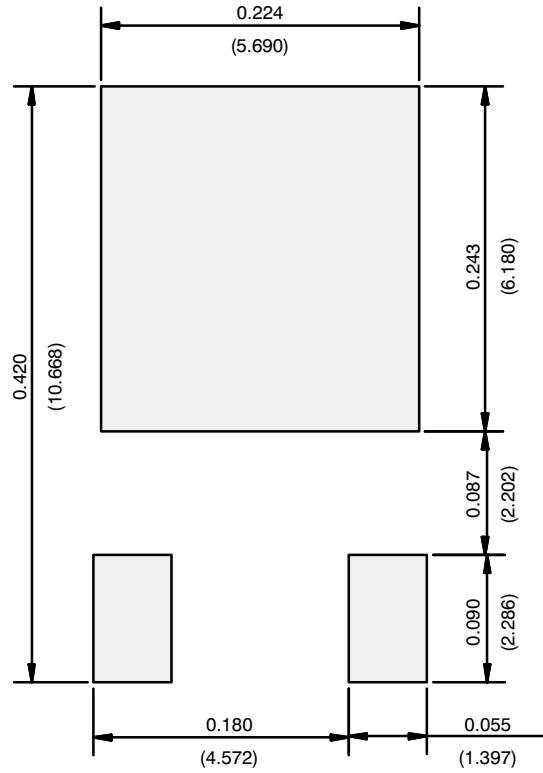
