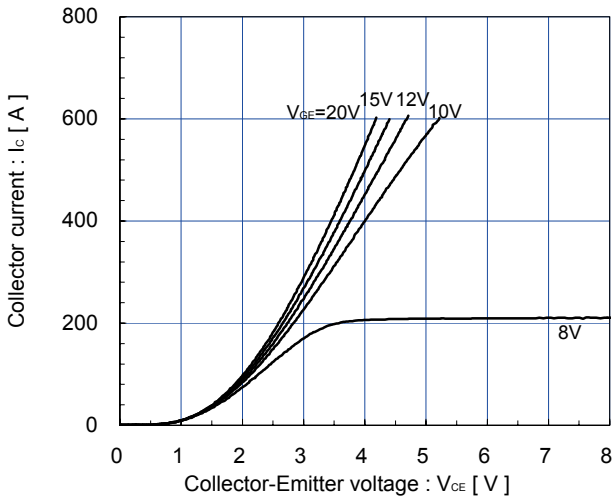

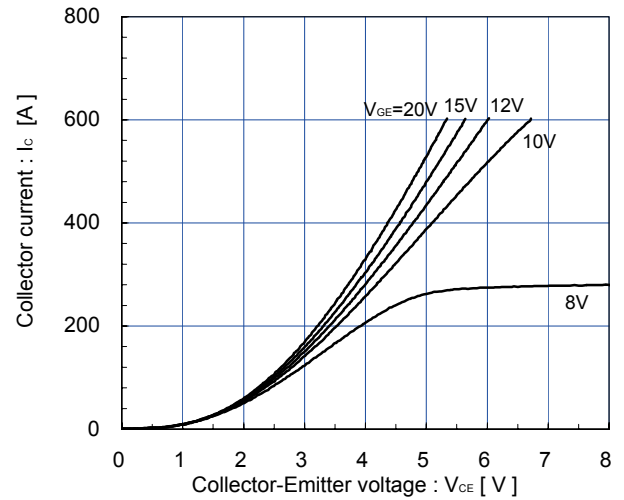

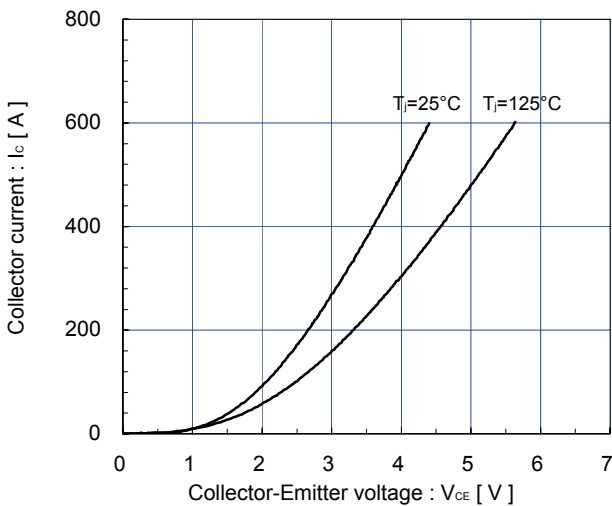
Collector current vs. Collector-Emitter voltage (typ.)
 $T_j=25^\circ\text{C}$ / chip



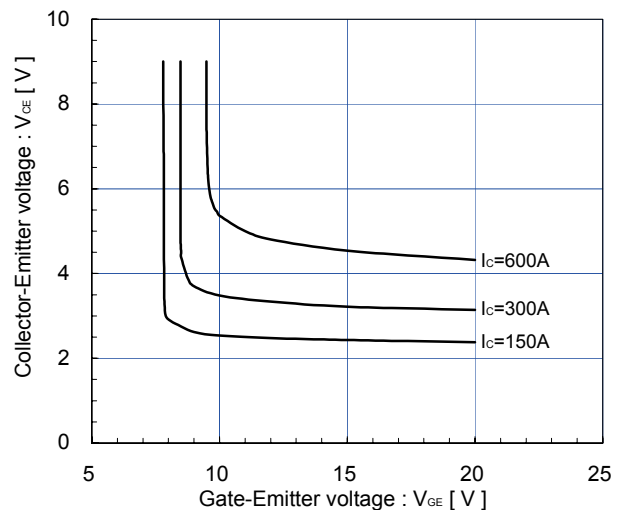
Collector current vs. Collector-Emitter voltage (typ.)
 $T_j=125^\circ\text{C}$ / chip



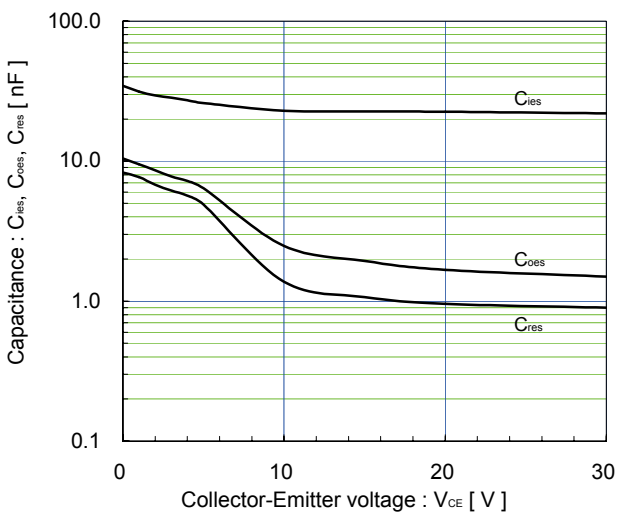
Collector current vs. Collector-Emitter voltage (typ.)
 $V_{GE}=15\text{V}$ / chip



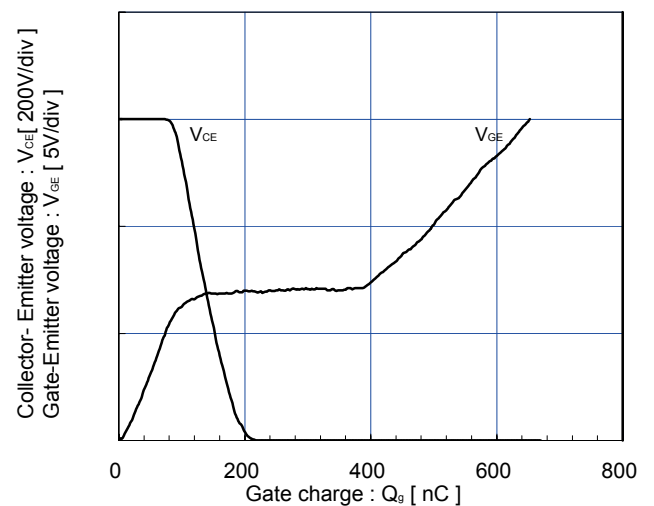
Collector-Emitter voltage vs. Gate-Emitter voltage (typ.)
 $T_j=25^\circ\text{C}$ / chip



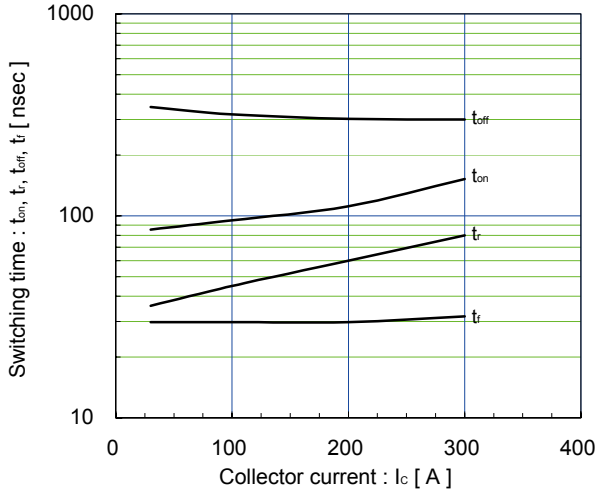
Capacitance vs. Collector-Emitter voltage (typ.)
 $V_{GE}=0\text{V}$, $f=1\text{MHz}$, $T_j=25^\circ\text{C}$



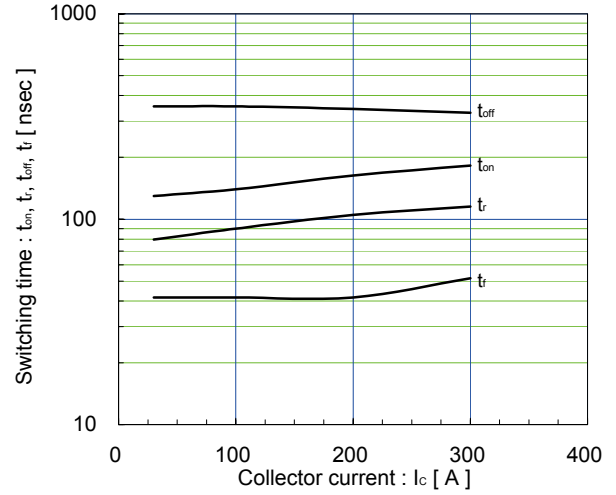
Dynamic Gate charge (typ.)

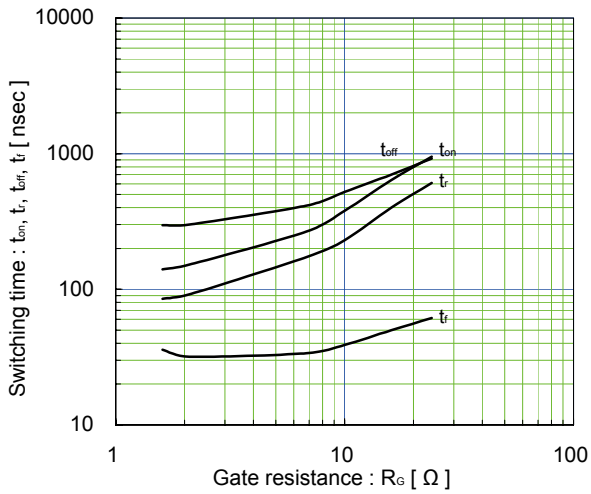
Switching time vs. Collector current (typ.)
 $V_{CC}=600V, V_{GE}=\pm 15V, R_G=2.1\Omega, T_J=25^\circ C$



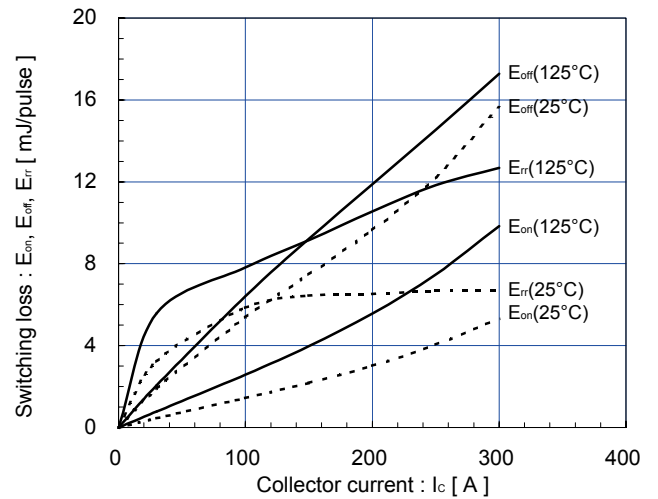
Switching time vs. Collector current (typ.)
 $V_{CC}=600V, V_{GE}=\pm 15V, R_G=2.1\Omega, T_J=125^\circ C$



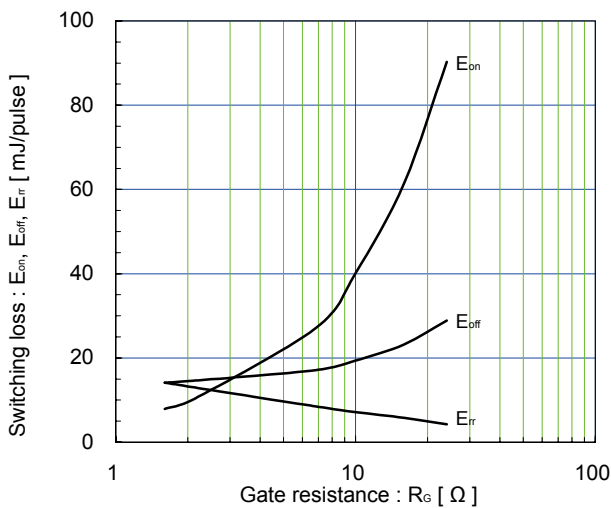
Switching time vs. Gate resistance (typ.)
 $V_{CC}=600V, I_c=300A, V_{GE}=\pm 15V, T_J=25^\circ C$



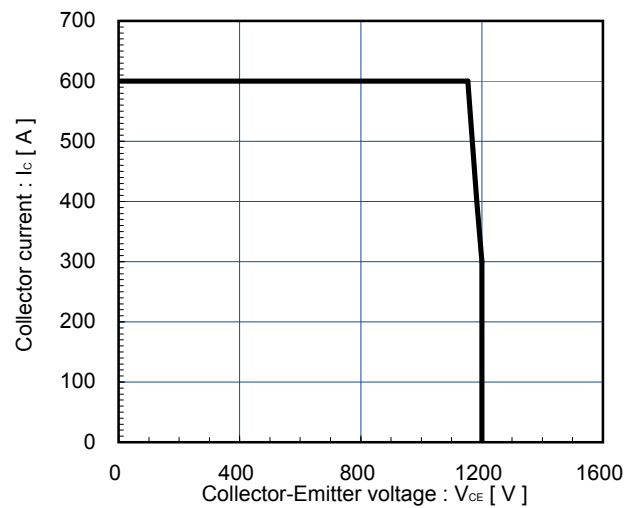
Switching loss vs. Collector current (typ.)
 $V_{CC}=600V, V_{GE}=\pm 15V, R_G=2.1\Omega$

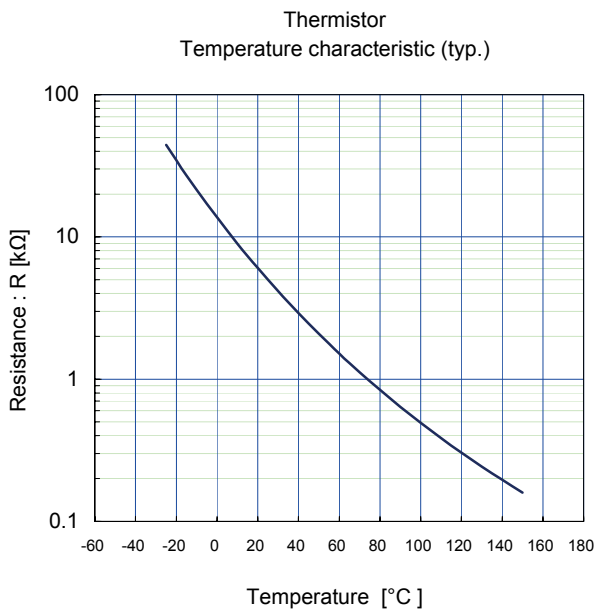
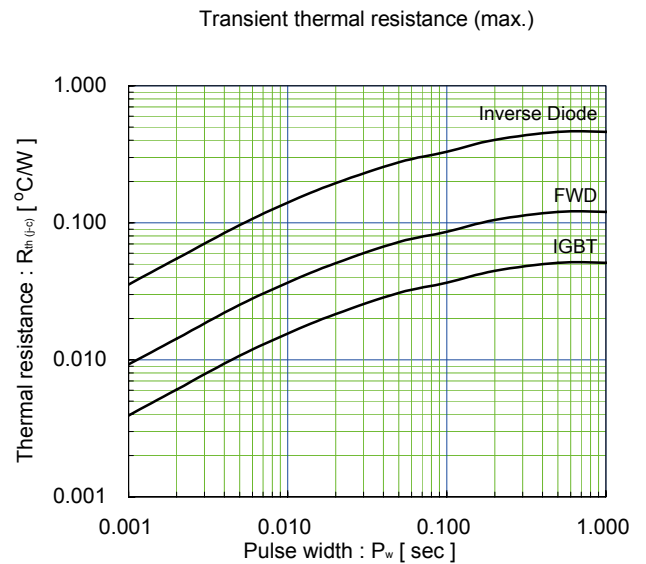
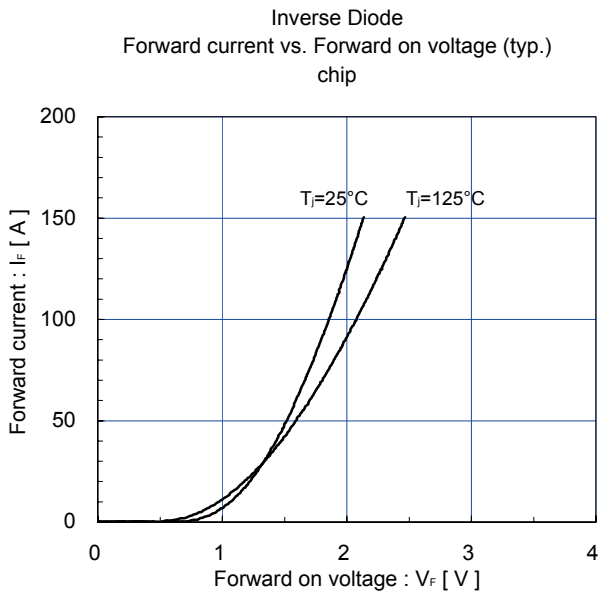
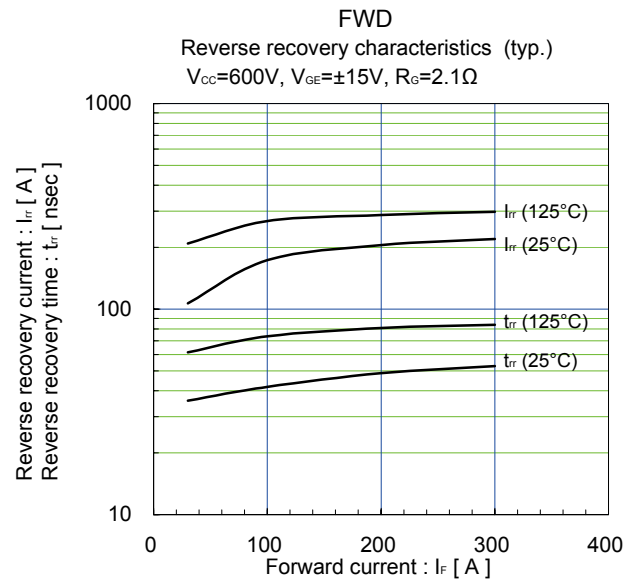
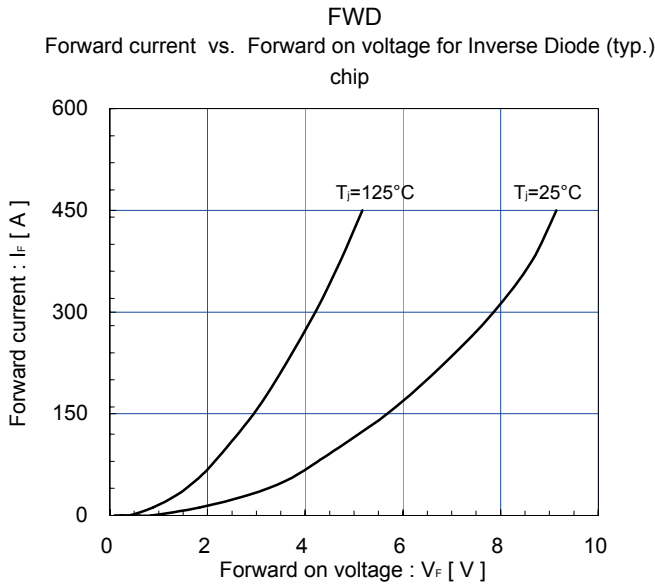


Switching loss vs. Gate resistance (typ.)
 $V_{CC}=600V, I_c=300A, V_{GE}=\pm 15V, T_J=125^\circ C$

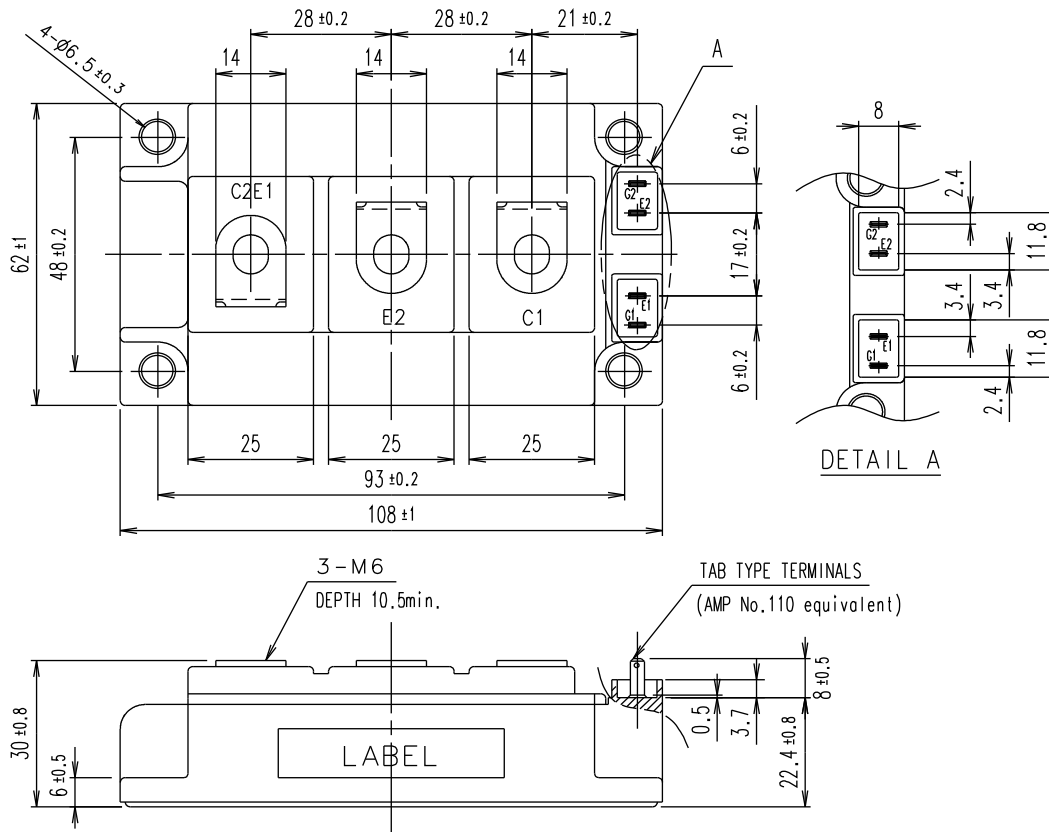


Reverse bias safe operating area (max.)

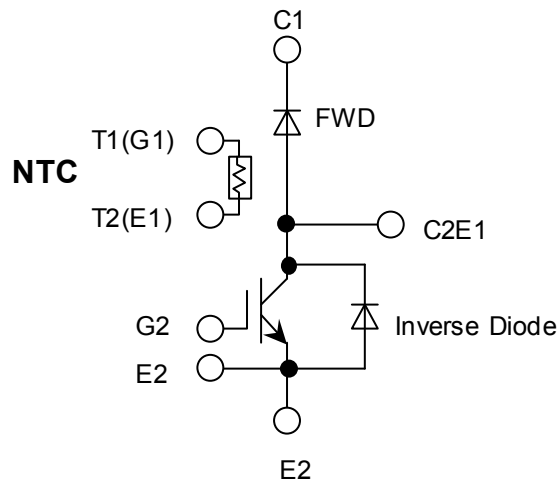
