


Forward Current vs. Collector Dissipation Temperature Rating




Light Current vs. Collector–Emitter Voltage Characteristics (EE-SH3(-B))




Response Time vs. Load Resistance Characteristics (Typical)




Sensing Position Characteristics (EE-SH3-G(S))




Forward Current vs. Forward Voltage Characteristics (Typical)




Relative Light Current vs. Ambient Temperature Characteristics (Typical)




Sensing Position Characteristics (EE-SH3-D(S))




Sensing Position Characteristics (EE-SH3-C(S))




Light Current vs. Forward Current Characteristics (Typical)




Dark Current vs. Ambient Temperature Characteristics (Typical)

Terms and Conditions of Sale
