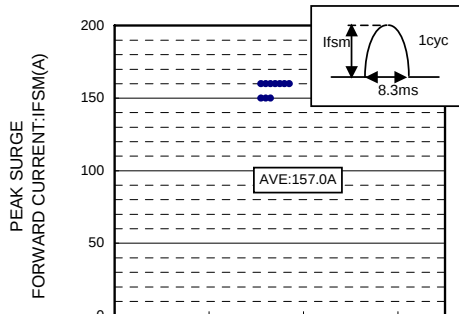
Vf DISPERSION MAP



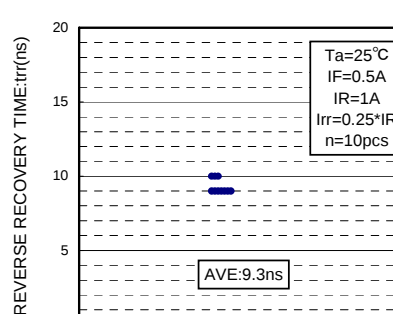
Ir DISPERSION MAP



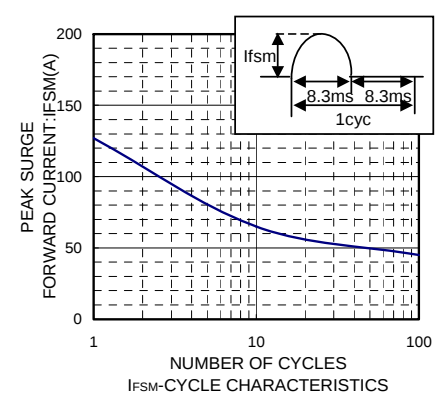

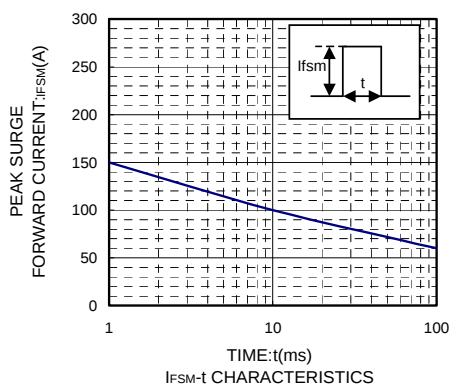
Ifsm DISERSION MAP



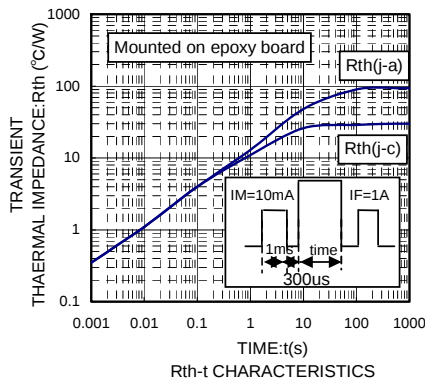

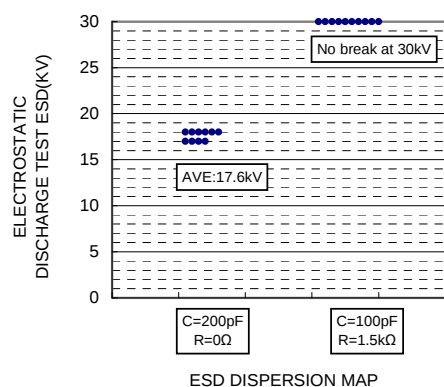
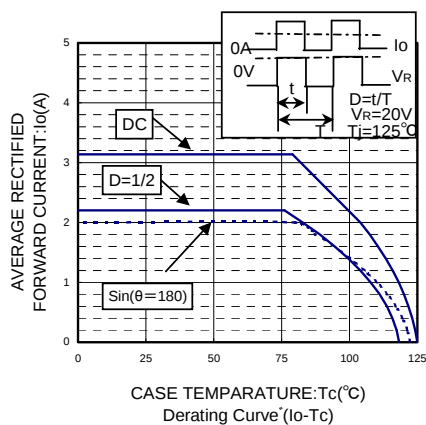
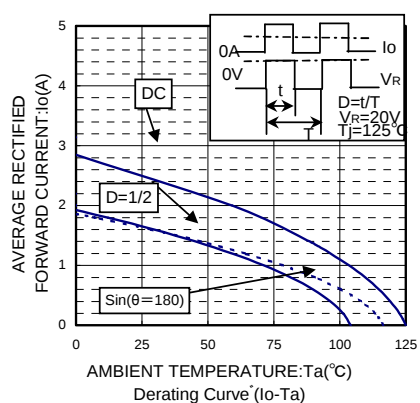
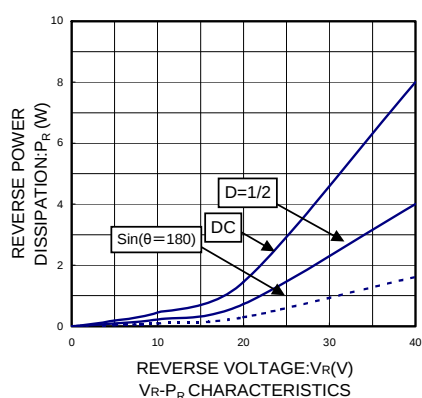


Ifsm-t CHARACTERISTICS
