The driver consists of a shift register for generating the sampling timing and sample & hold circuits for sampling the analog voltage. The high picture quality obtained by the alternate sample & hold execution of the two types of on-chip sample & hold circuits enables employment in applications such as car navigation panels.

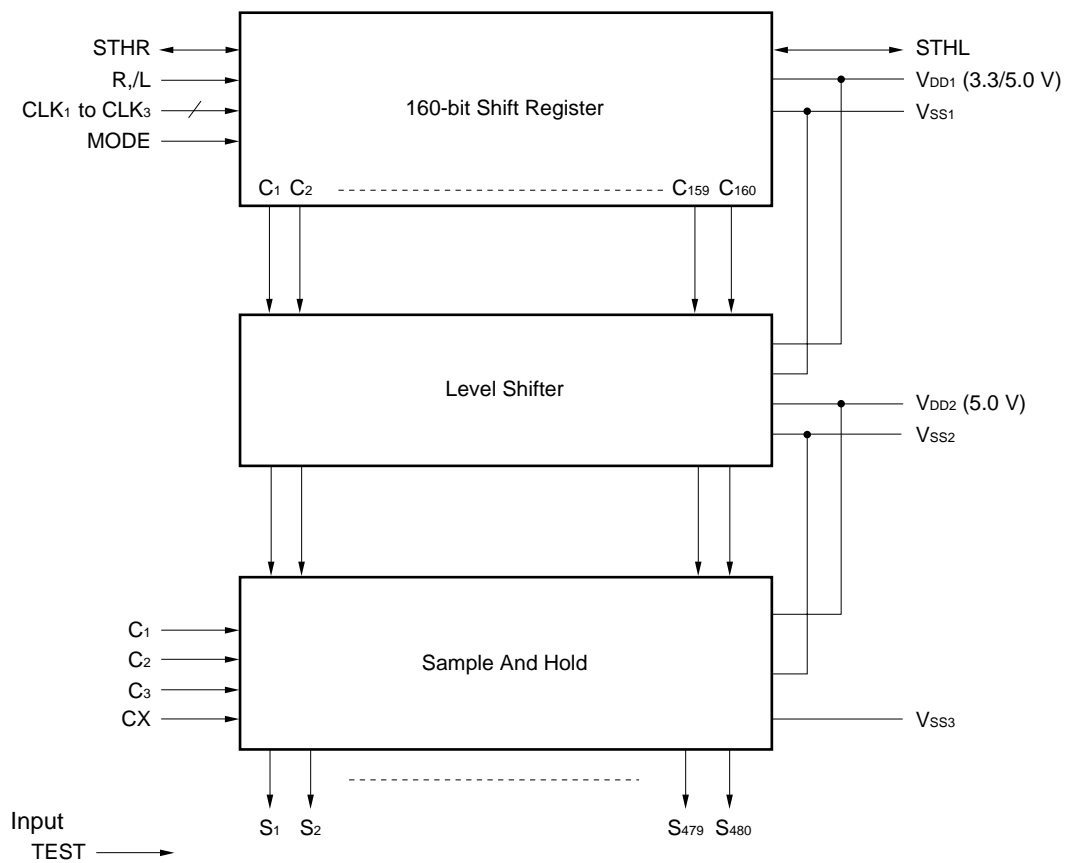

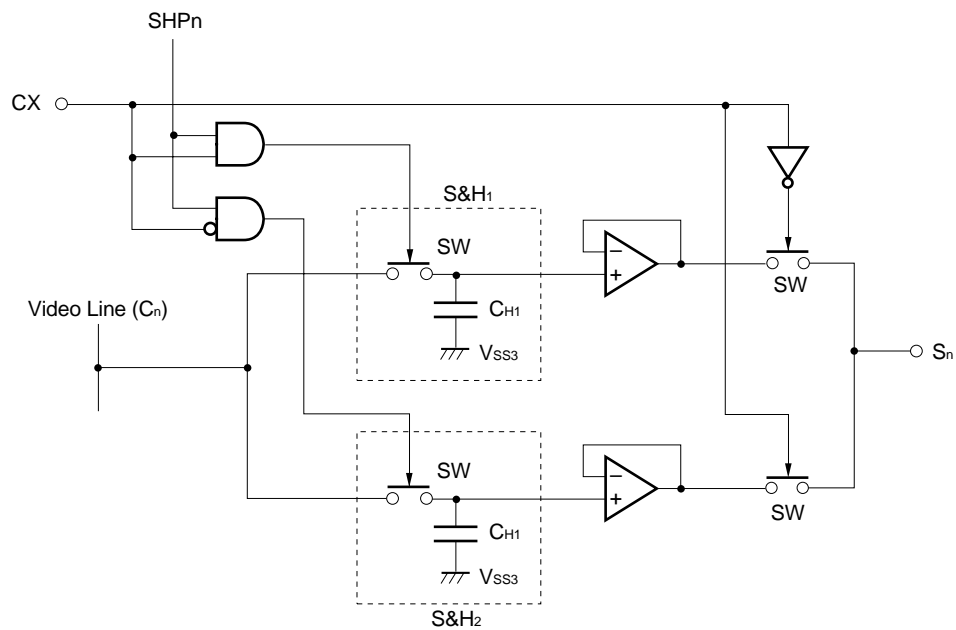

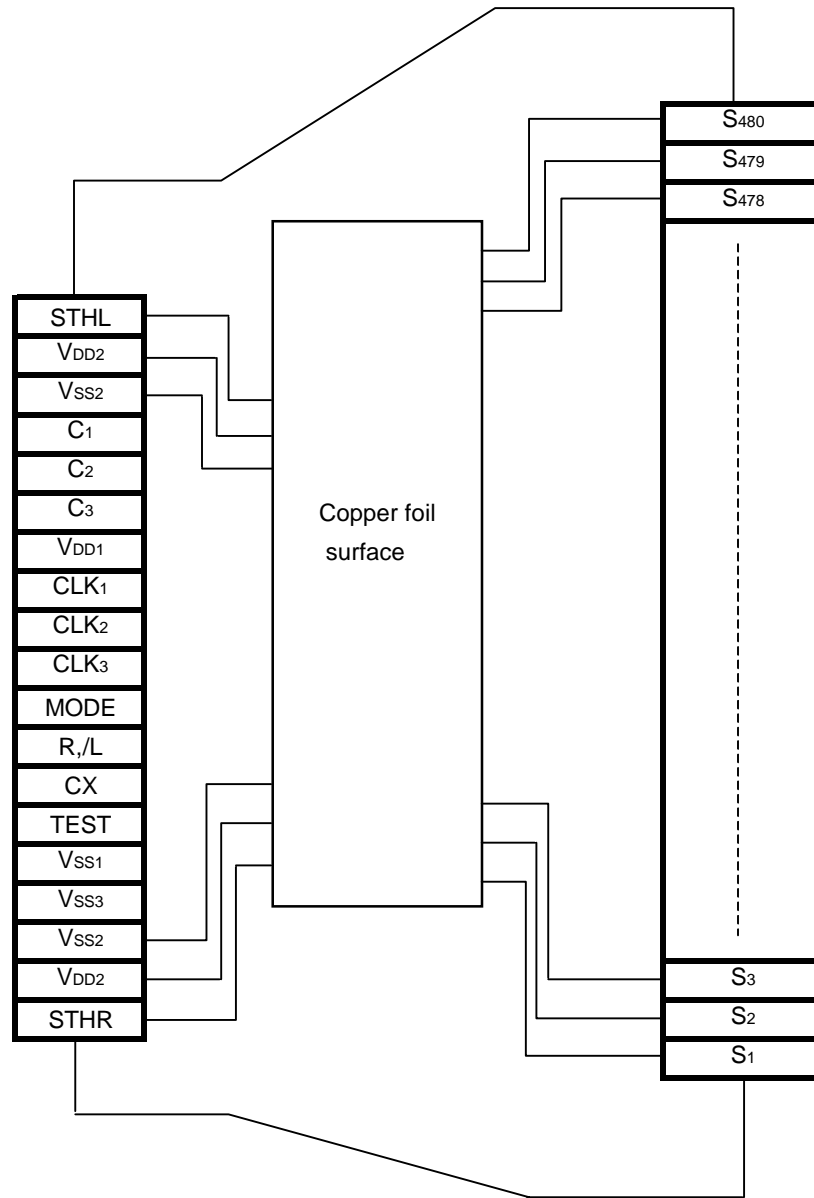
★ 1. BLOCK DIAGRAM

- Cautions**
1. To prevent latch-up-breakdown, the power should be turned on in order V_{DD1}, Logic input V_{DD2}, video signal input. It should be turned off in the opposite order. This relationship should be followed during transition periods as well.
 2. The sampling of the video signal of this IC is only the simultaneous 3 output sampling of C₁ to C₃. Incidentally, it is designing abound of the input of the video signal in 10 MHz MAX. If a video signal with a higher frequency is input, the data may not be correctly displayed.
 3. Recommend a bypass capacitor of about 0.1 μF with good high-frequency characteristics between V_{DD1} and V_{SS1}, and V_{DD2} and V_{SS2} in each driver IC. Unless the power supply is reinforced, the supply voltage may fluctuate, making the sampling voltage abnormal.
 4. If noise is superimposed on the start pulse pin, the data may not be displayed. For this reason, be sure to input CX signal during the vertical blanking period.
 5. If the start pulse width is extended by half the clock or longer, the sampling start timing SHP1 does not change from normal timing; therefore, the sampling operation is performed normally.

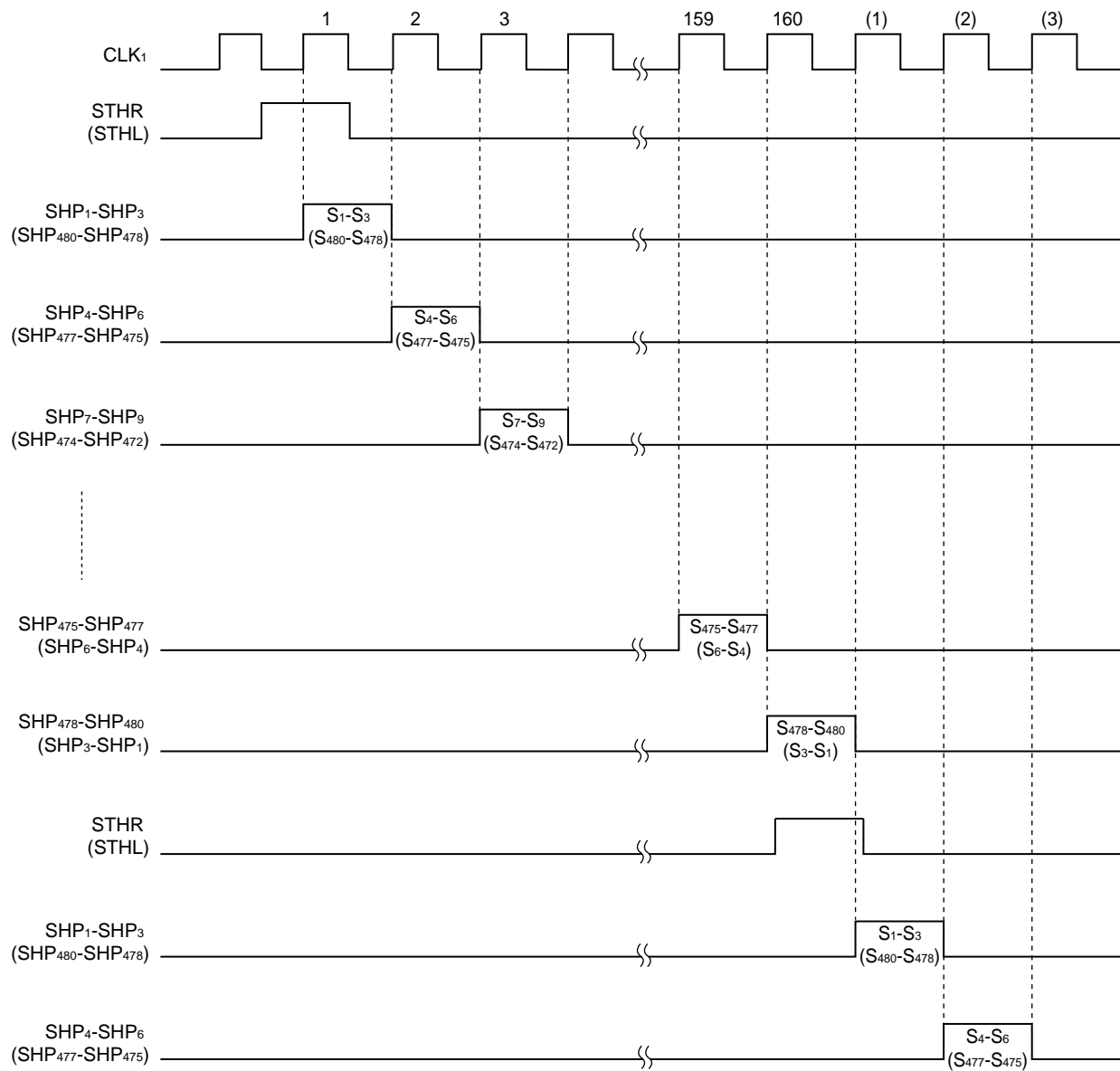

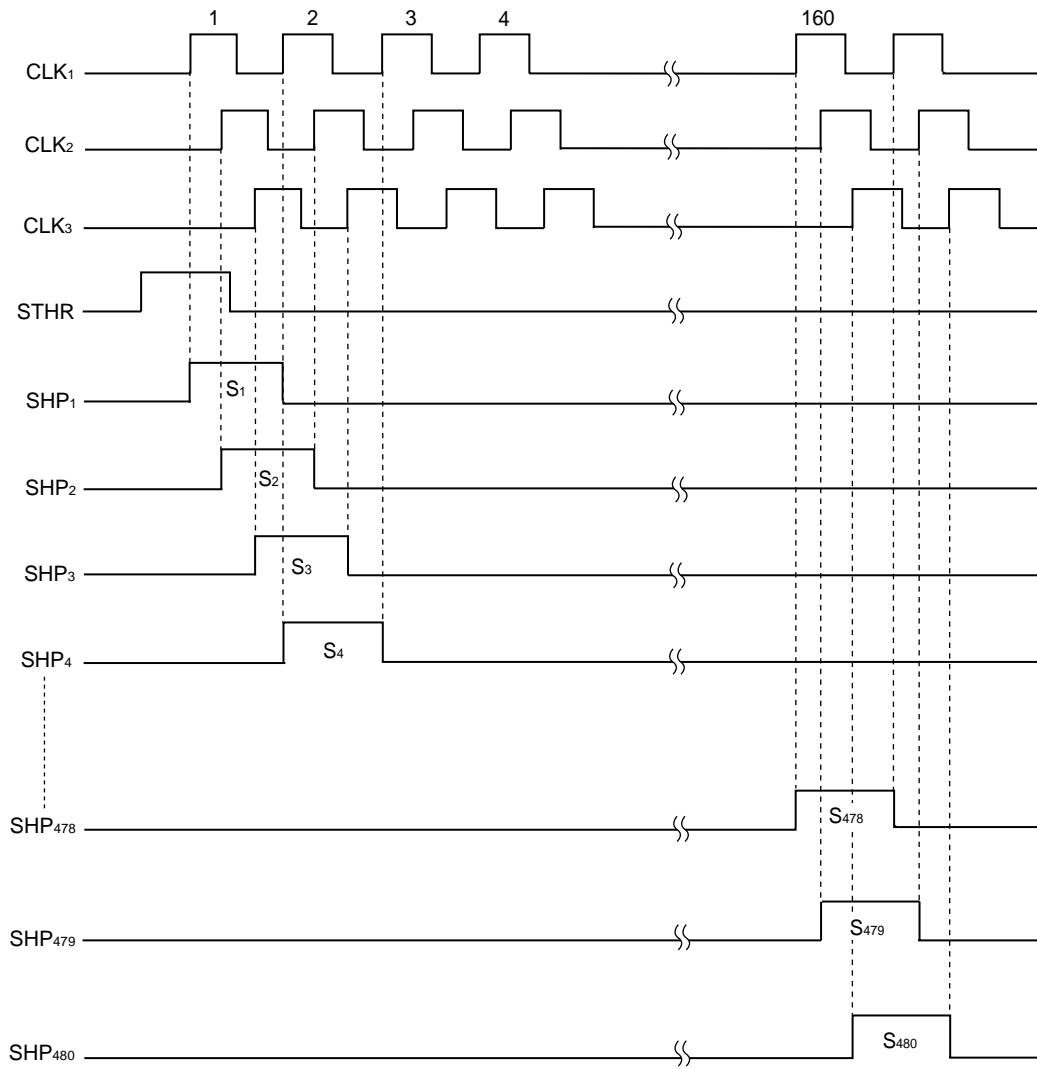

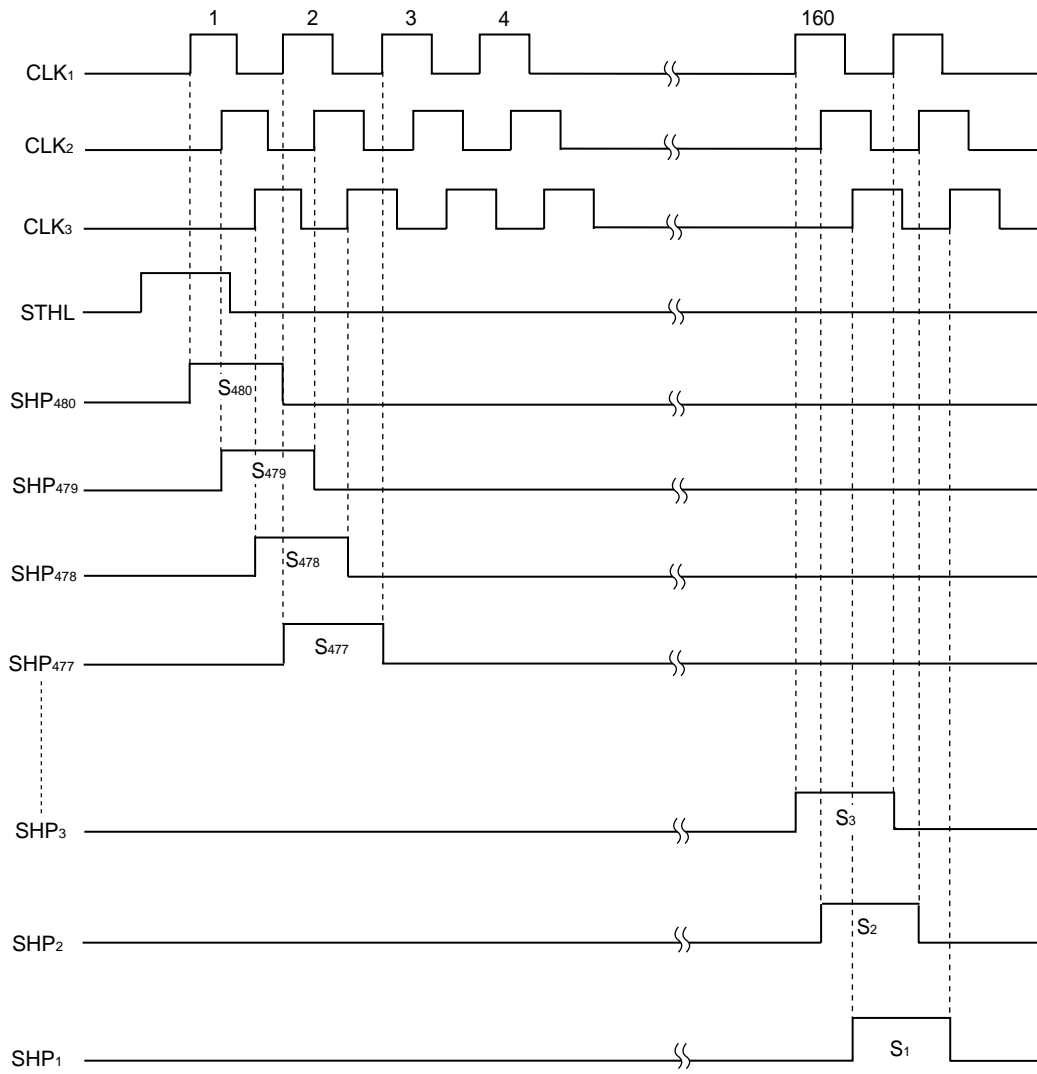
6.1 1-Phase Simultaneous Sampling

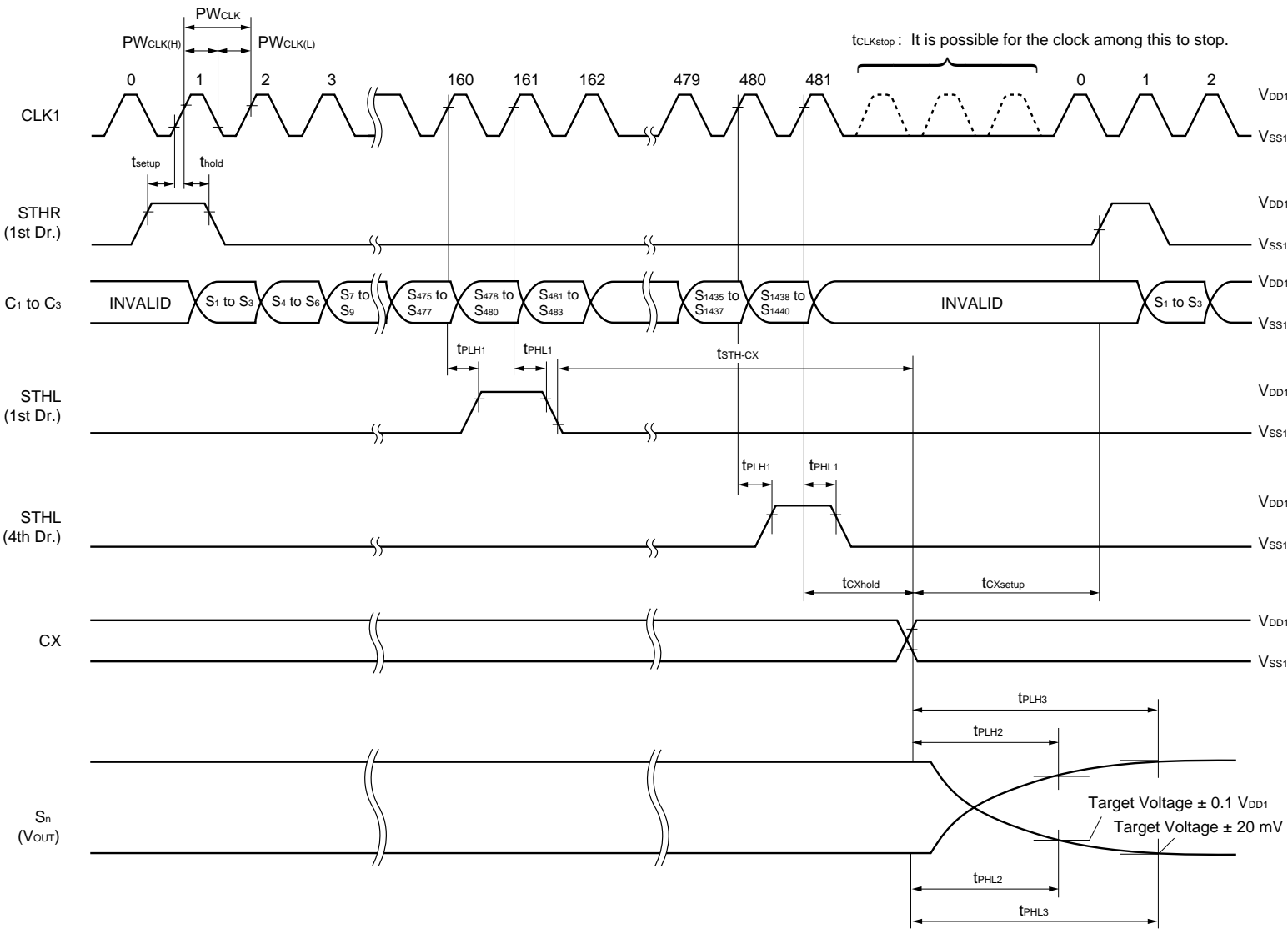

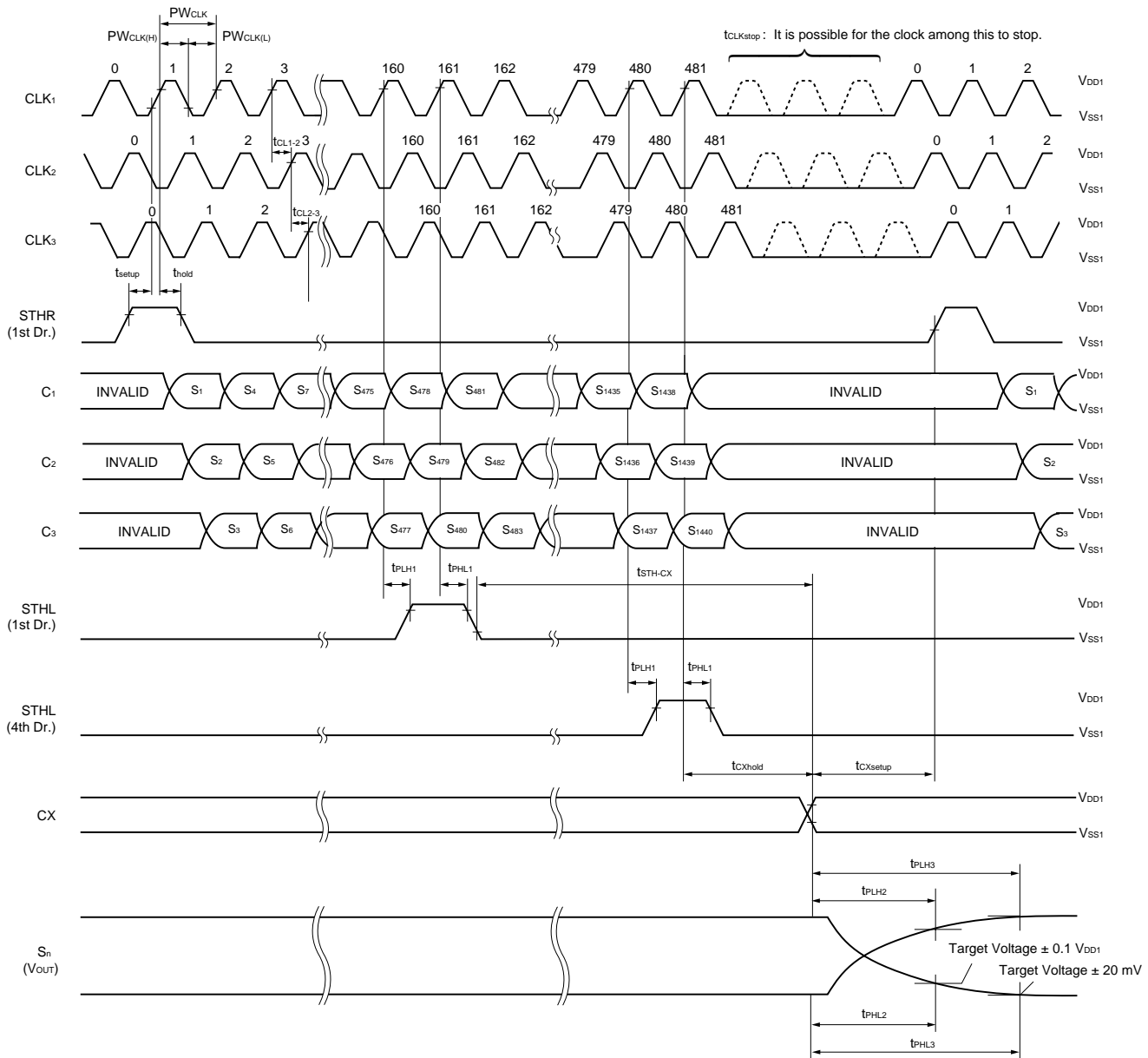

NOTES FOR CMOS DEVICES**① PRECAUTION AGAINST ESD FOR SEMICONDUCTORS**

Note:

Strong electric field, when exposed to a MOS device, can cause destruction of the gate oxide and ultimately degrade the device operation. Steps must be taken to stop generation of static electricity as much as possible, and quickly dissipate it once, when it has occurred. Environmental control must be adequate. When it is dry, humidifier should be used. It is recommended to avoid using insulators that easily build static electricity. Semiconductor devices must be stored and transported in an anti-static container, static shielding bag or conductive material. All test and measurement tools including work bench and floor should be grounded. The operator should be grounded using wrist strap. Semiconductor devices must not be touched with bare hands. Similar precautions need to be taken for PW boards with semiconductor devices on it.

② HANDLING OF UNUSED INPUT PINS FOR CMOS

Note:

No connection for CMOS device inputs can be cause of malfunction. Each unused pin should be connected to V_{DD} or GND with a resistor, if it is considered to have a possibility of being an output pin. All handling related to the unused pins must be judged device by device and related specifications governing the devices.

"Special": Transportation equipment (automobiles, trains, ships, etc.), traffic control systems, anti-disaster systems, anti-crime systems, safety equipment and medical equipment (not specifically designed for life support)
"Specific": Aircraft, aerospace equipment, submersible repeaters, nuclear reactor control systems, life support systems and medical equipment for life support, etc.

The quality grade of NEC semiconductor products is "Standard" unless otherwise expressly specified in NEC's data sheets or data books, etc. If customers wish to use NEC semiconductor products in applications not intended by NEC, they must contact an NEC sales representative in advance to determine NEC's willingness to support a given application.
