


Fig. 1 - Maximum Forward Currernt Derating Curve




Fig. 2 - Forward Power Loss Characteristics




Fig. 3 - Typical Instantaneous Forward Characteristics




Fig. 4 - Typcial Reverse Leakage Characteristics




Fig. 5 - Typical Junction Capacitance




Fig. 6 - Typcial Transient Thermal Impedance





Fig. 7 - Thermal Resistance Junction to Ambient vs. Copper Pad Areas
