

N-Channel 40-V (D-S) MOSFET

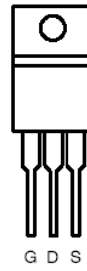

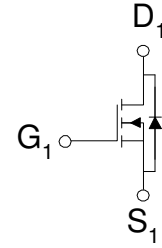
