The recent unprecedented industry-wide economic downturn has prompted LSI to examine their pending process migration plans and has required them to accelerate End of Life on their older process lines. This impacts their 60XK technology. LSI intends to cease manufacturing of these products in Q3, 2002.

This unprecedented notice from LSI with very short window in delivering our total product requirements has forced Mindspeed/Conexant to end of life the CN8330EPJD/EPFD (Mindspeed/Conexant internal # 28330-13 or 28330-14) product. This device is therefore being discontinued.
