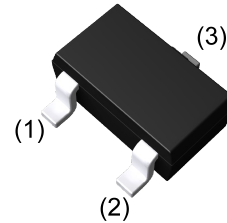

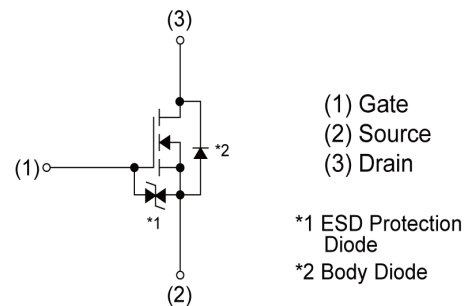

Fig.1 Power Dissipation Derating Curve

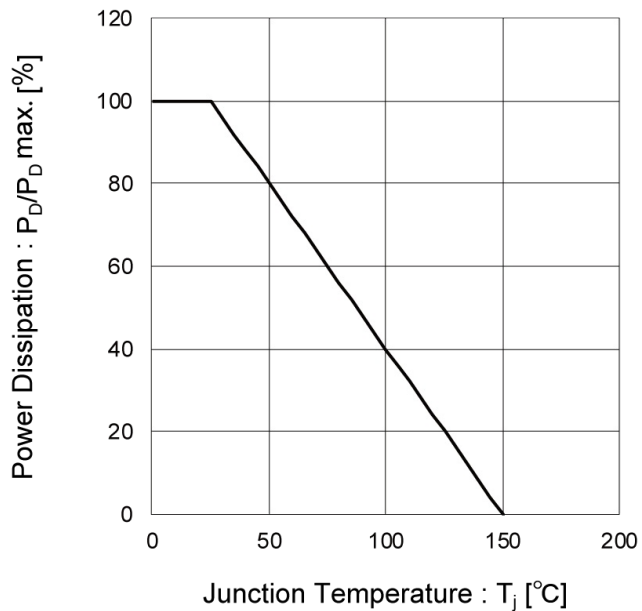


Fig.2 Drain Current Derating Curve

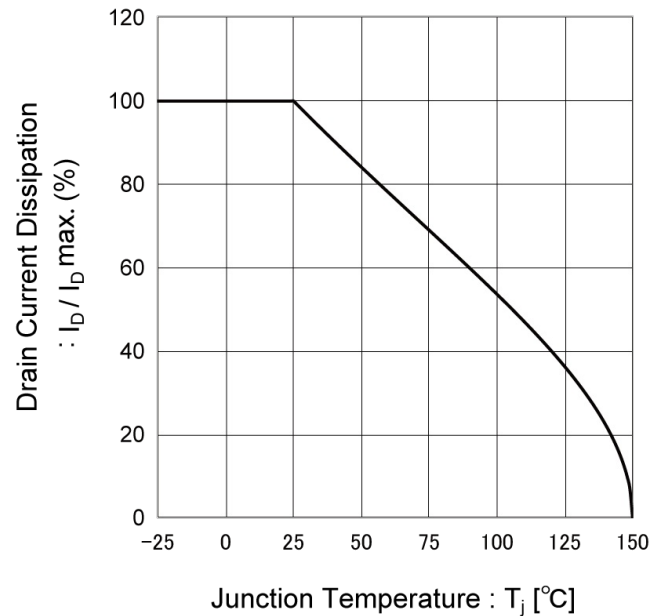
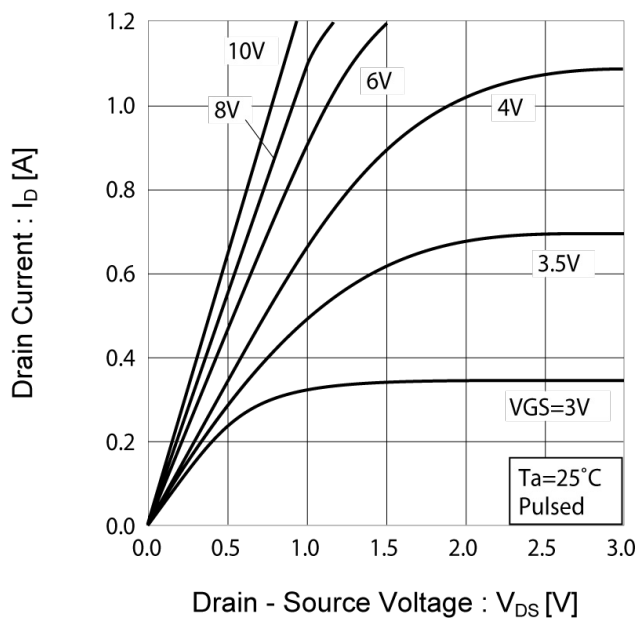


Fig.3 Typical Output Characteristics(I)

Junction Temperature

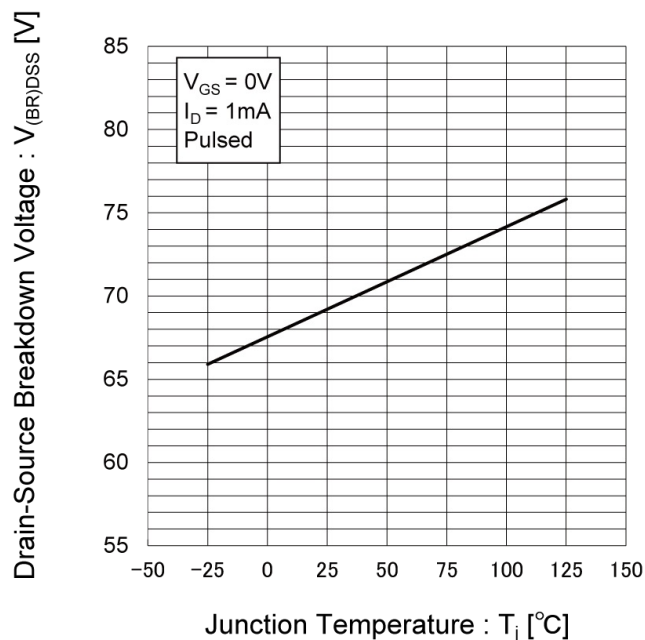


Fig.5 Typical Transfer Characteristics

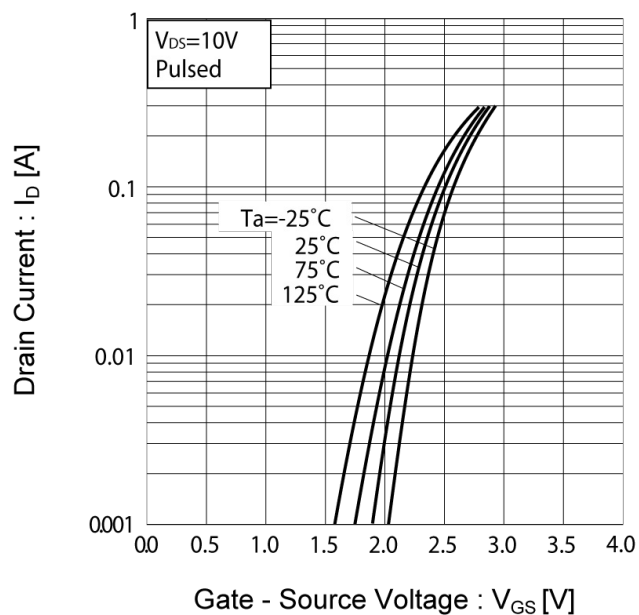
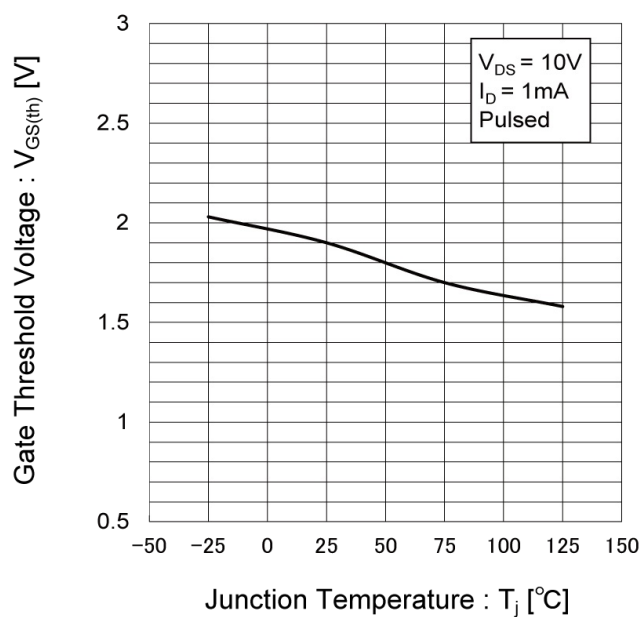


Fig.6 Gate Threshold Voltage vs.

Fig.7 Forward Transfer Admittance vs. Drain Current

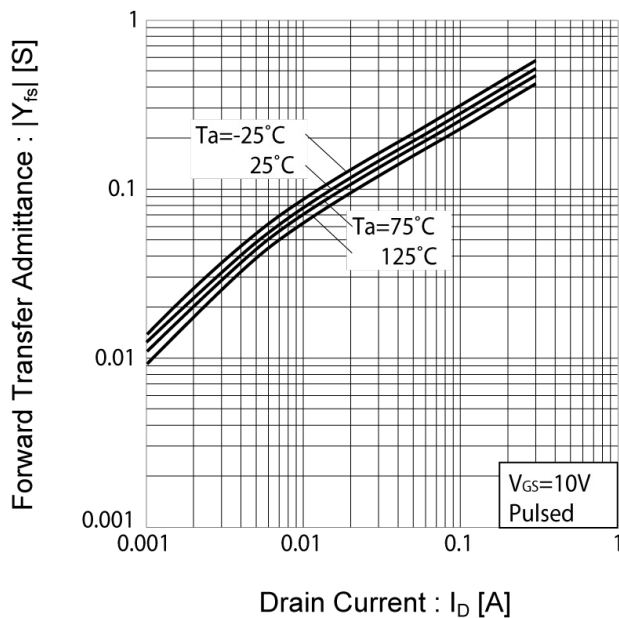


Fig.8 Static Drain - Source On - State Resistance vs. Gate Source Voltage

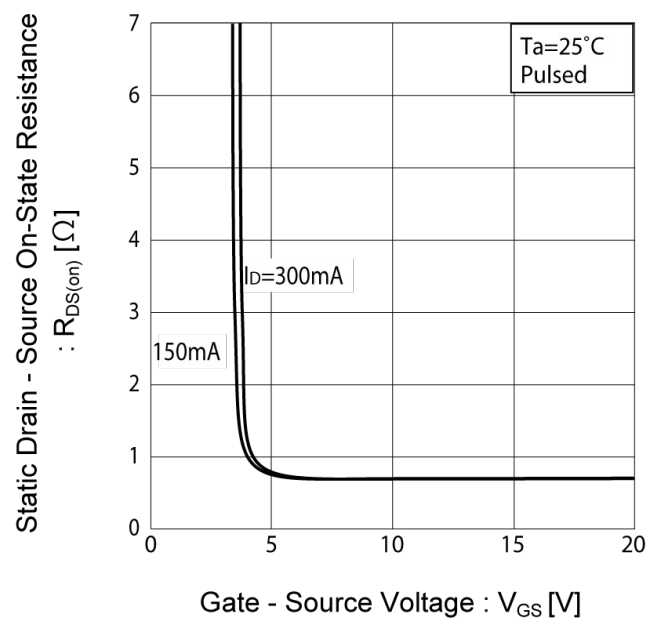
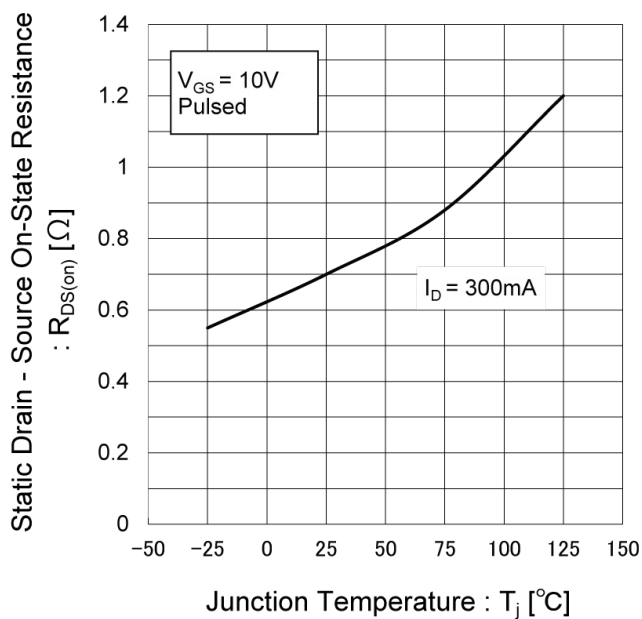


Fig.9 Static Drain - Source On - State Resistance vs. Junction Temperature

Fig.10 Static Drain - Source On - State Resistance vs. Drain Current (I)

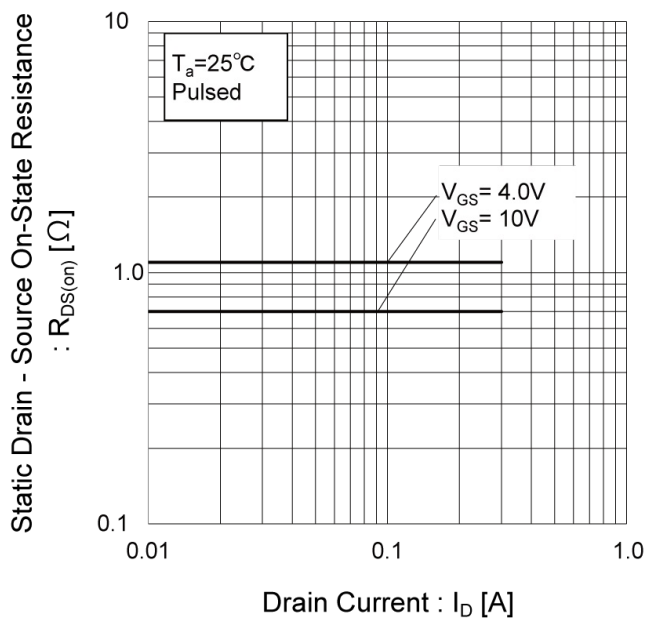


Fig.11 Static Drain - Source On - State Resistance vs. Drain Current (II)

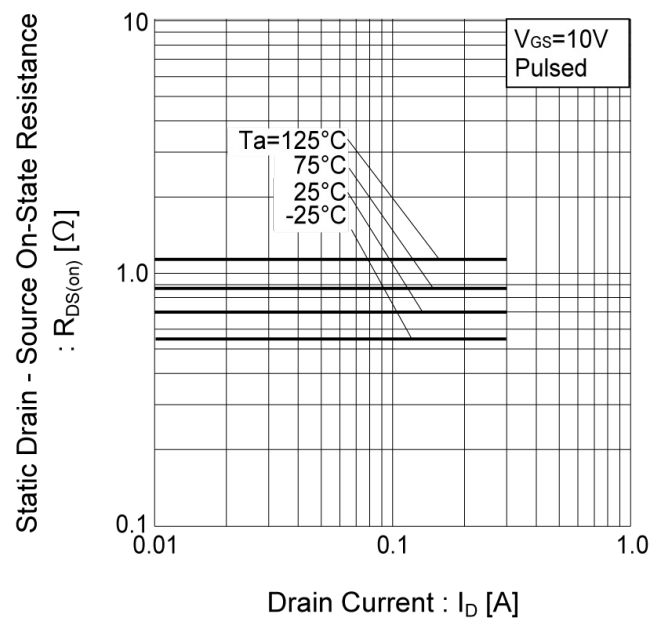
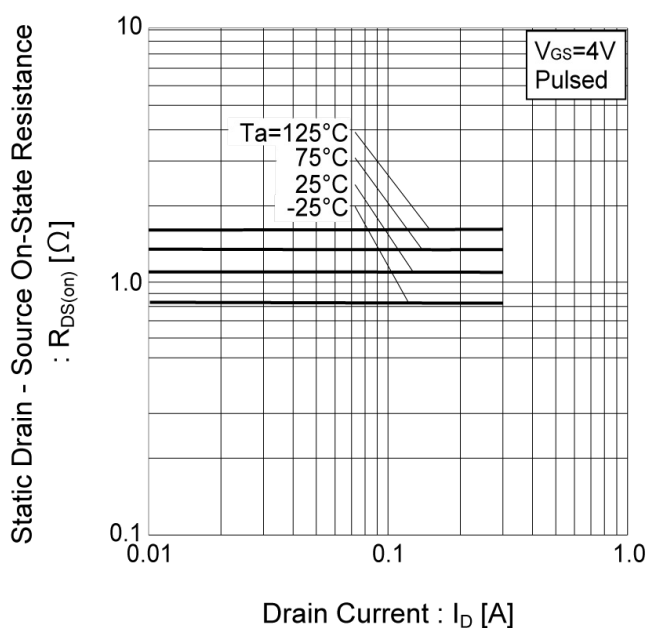


Fig.12 Static Drain - Source On - State Resistance vs. Drain Current (III)

Drain - Source Voltage

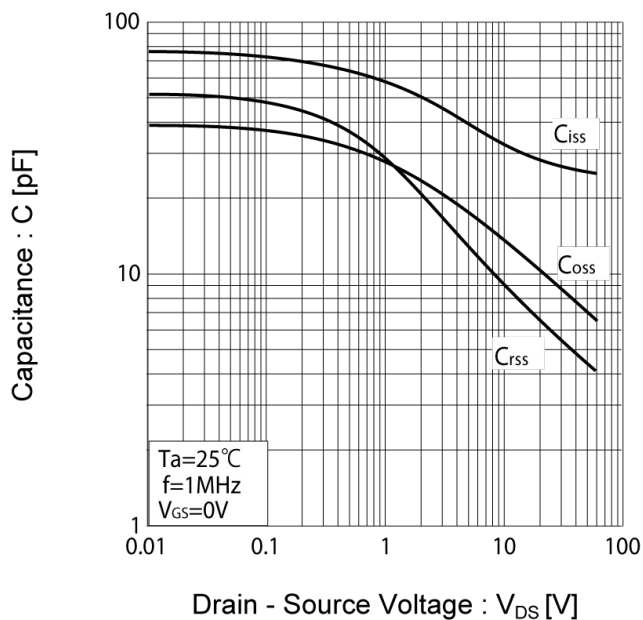


Fig.14 Switching Characteristics

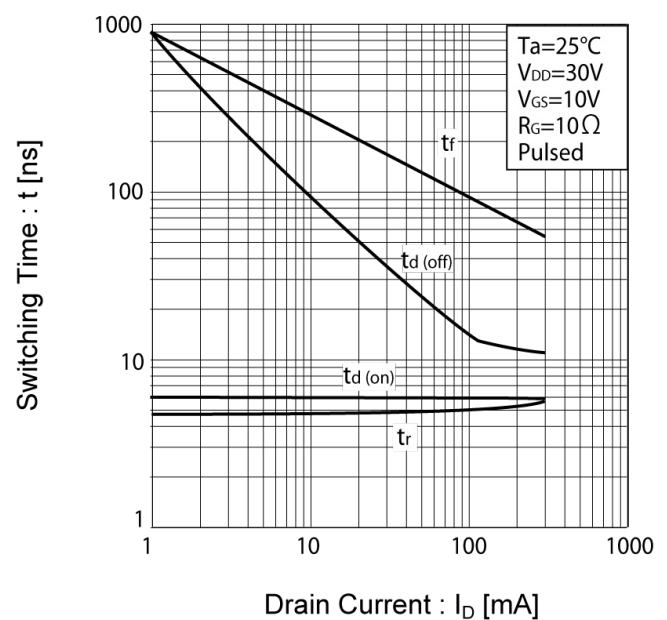
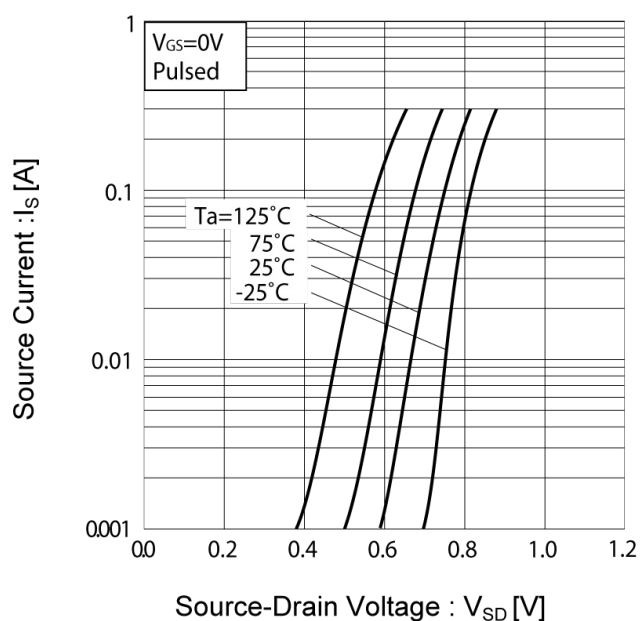


Fig.15 Source Current vs.

Fig. 1-1 SWITCHING TIME MEASUREMENT CIRCUIT

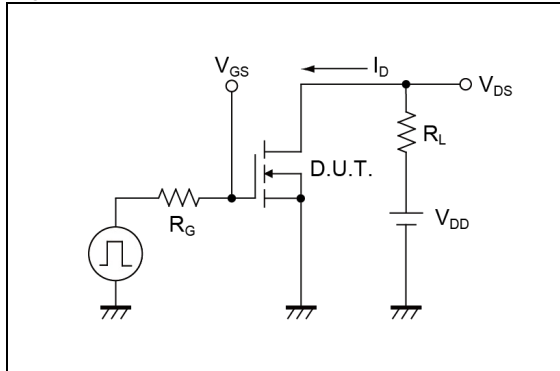
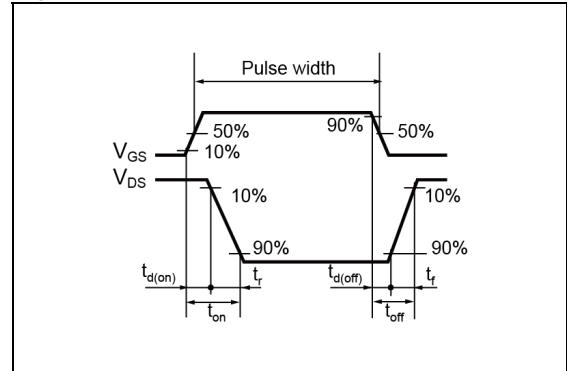


Fig. 1-2 SWITCHING WAVEFORMS

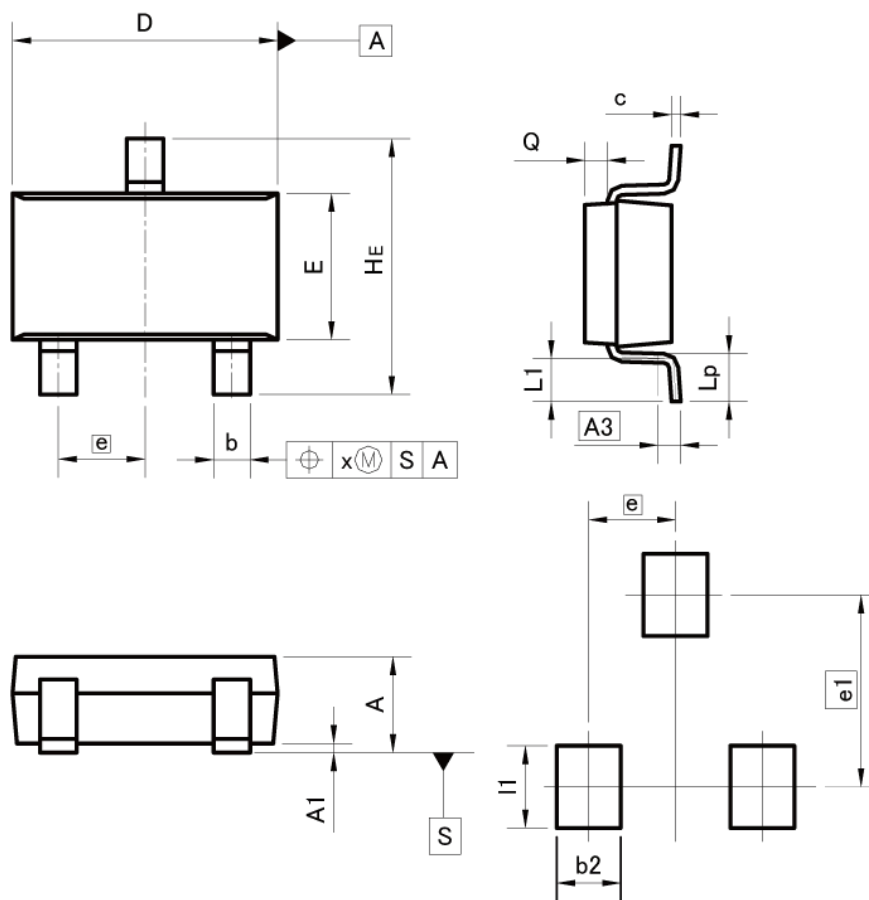
