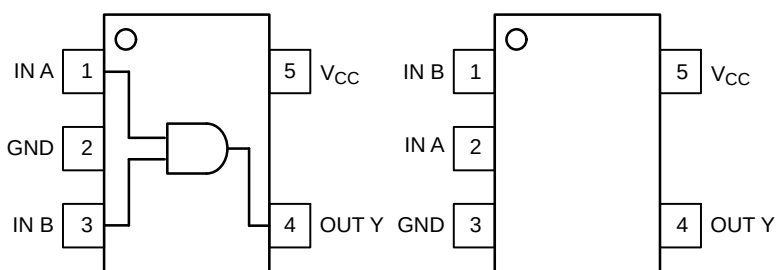


Figure 1. SOT-953

(Top View)

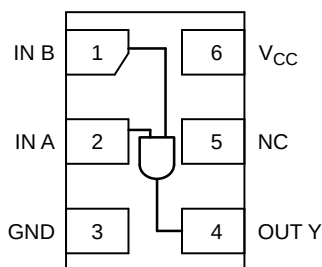


Figure 1. UDFN6
(Top View)

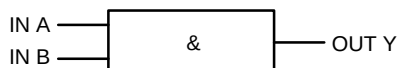


Figure 2. Logic Symbol



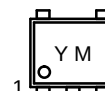

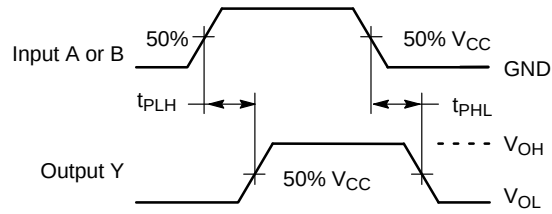
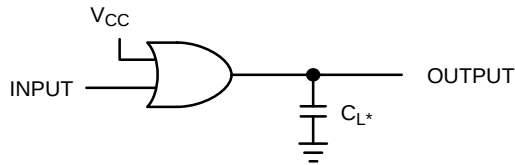


Figure 2. Switching Waveforms

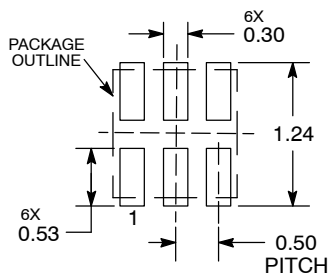

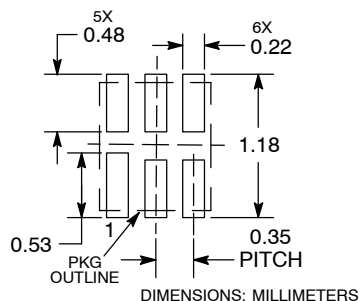
