




#### PERFORMANCE CURVES






OUTPUT CHARACTERISTICS

(TYPICAL)




MAXIMUM SAFE OPERATING AREA



DRAIN-SOURCE VOLTAGE VDs (V)









DRAIN CURRENT ID (A)


