The Evaluation Board shall not be, in any case, directly or indirectly assembled as a part in any production of Yours as it is solely developed to serve evaluation purposes and has no direct function and is not a finished product. If software and/or firmware is accompanied by a separate end user license agreement ("EULA"), then such software and/or firmware shall be governed by such EULA.

### **EVALUATION BOARD STATUS**

The Evaluation Board offers limited features allowing You only to evaluate and test the ST products. The Evaluation Board is not intended for consumer or household use. You are not authorized to use the Evaluation Board in any production system, and it may not be offered for sale or lease, or sold, leased or otherwise distributed for commercial purposes.
