

TPD4E1U06DCKEVM

The TPD4E1U06 is a quad channel ultra low cap ESD protection device. It offers $\pm 15\text{KV}$ IEC air-gap and $\pm 15\text{KV}$ contact ESD protection. Its 0.8pF line capacitance makes it suitable for a wide range of applications. Typical application areas are HDMI, USB2.0, MHL, and DisplayPort.

2 EVM Description and Configuration

The TPD4E1U06DCKEVM is designed to allow 4-port analysis through a $100\ \Omega$ TMDS line, or differential pair. The board material is Rogers Board RO4350 with a Dielectric Constant, ϵ_r , of 3.48 ± 0.05 and a loss tangent, δ , of 0.0031 at $2.5\ \text{GHz}$. The port connectors are surface-mount SMP $50\ \Omega$ high speed connectors.

The EVM has two sections: CALIBRATION and TPD4E1U06DCK. The traces on the CALIBRATION section are identical to the traces on the TPD4E1U06DCK section, allowing the board's effect to be removed and only the device under test's performance to be evaluated, without having to de-solder the device under test.

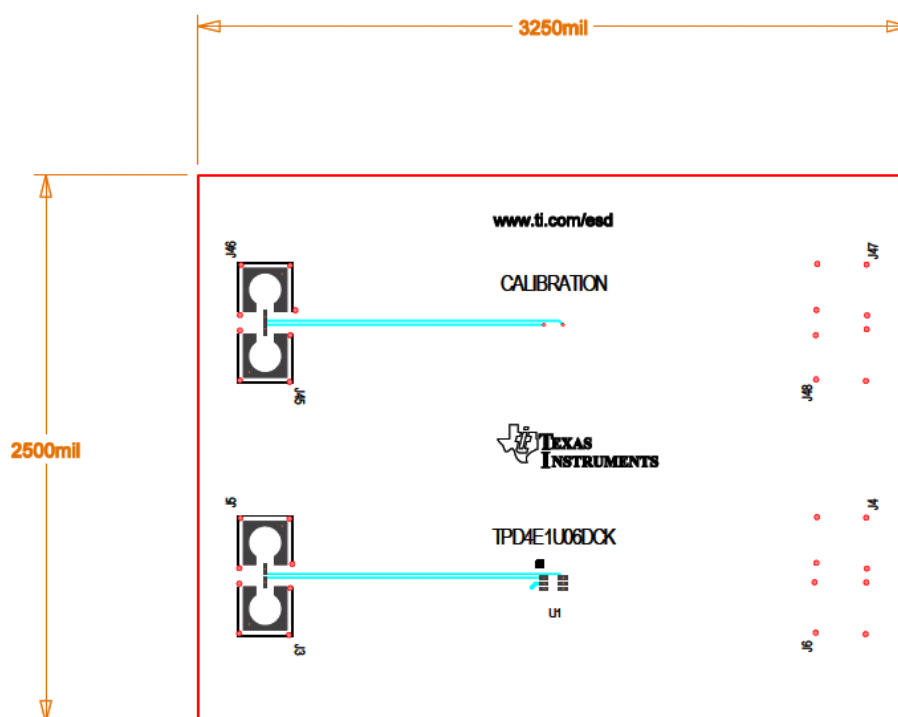
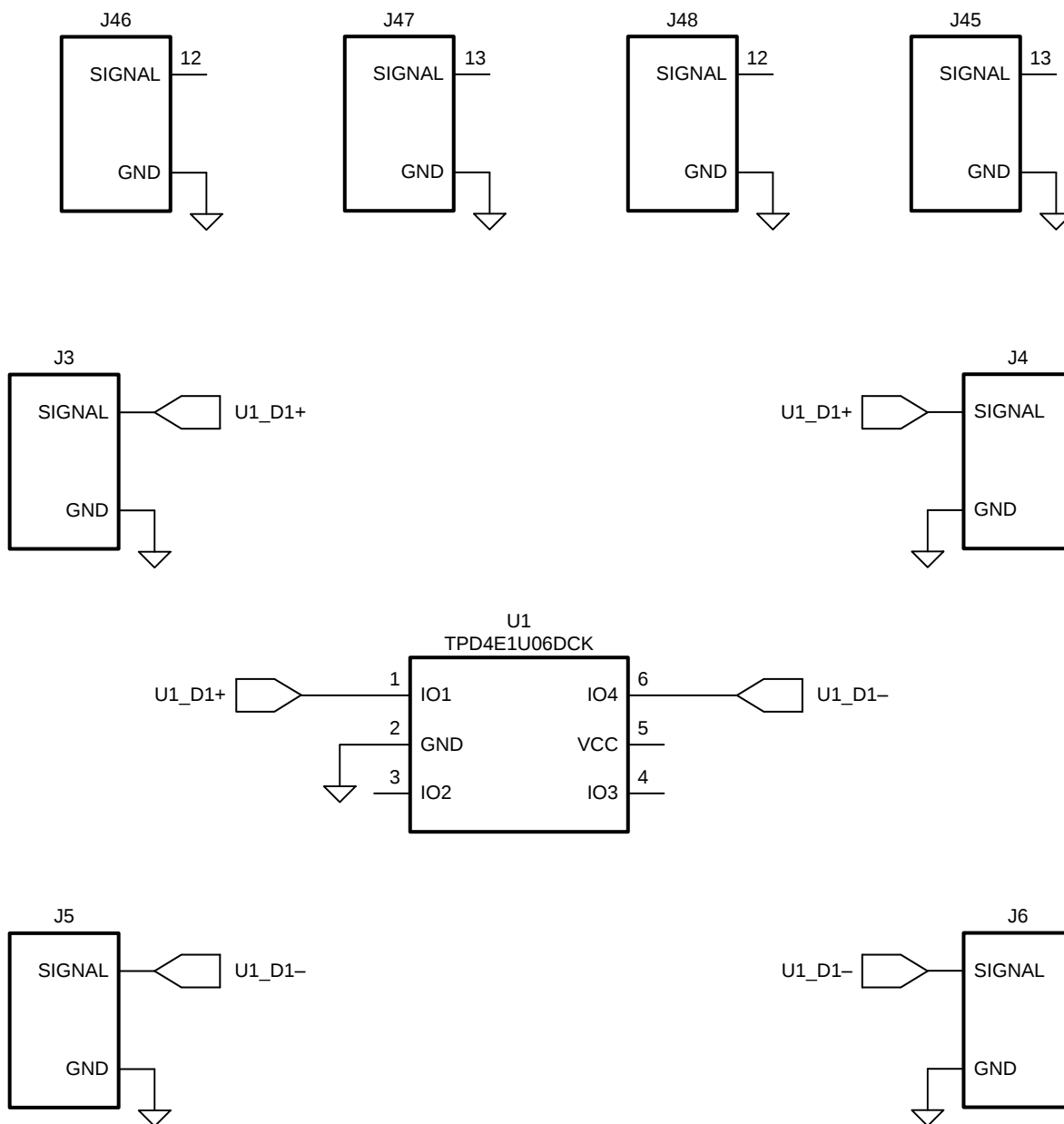
