1 Introduction

The TPS54525 is a single, adaptive on-time, D-CAP2™-mode, synchronous buck converter requiring a very low external component count. The D-CAP2™ control circuit is optimized for low-ESR output capacitors such as POSCAP, SP-CAP, or ceramic types and features fast transient response with no external compensation. The switching frequency is internally set at a nominal 650 kHz. The high-side and low-side switching MOSFETs are incorporated inside the TPS54525 package along with the gate drive circuitry. The low drain-to-source on resistance of the MOSFETs allow the TPS54525 to achieve high efficiencies and helps keep the junction temperature low at high output currents. The TPS54525 dc/dc synchronous converter is designed to provide up to a 5.5-A output from an input voltage source of 4.5 V to 18 V. The output voltage range is from 0.76 V to 5.5 V. Rated input voltage and output current ranges for the evaluation module are given in Table 1.

The TPS54525EVM-608 evaluation module is a single, synchronous buck converter providing 1.05 V at 5.5 A from 5-V to 18-V input. This user's guide describes the TPS54525EVM-608 performance.

2 Performance Specification Summary

A summary of the TPS54525EVM-608 performance specifications is provided in Table 2. Specifications are given for an input voltage of VIN = 12 V and an output voltage of 1.05 V, unless otherwise noted. The ambient temperature is 25°C for all measurement, unless otherwise noted.

3 Modifications

These evaluation modules are designed to provide access to the features of the TPS54525. Some modifications can be made to this module.

3.1 Output Voltage Setpoint

To change the output voltage of the EVMs, it is necessary to change the value of resistor R1. Changing the value of R1 can change the output voltage above 0.765 V. The value of R1 for a specific output voltage can be calculated using Equation 1 and Equation 2.

For output voltage from 0.76 V to 2.5 V:

$$VO = 0.765 \times \left(1 + \frac{R1}{R2}\right) \tag{1}$$

For output voltage over 2.5 V:

$$VO = (0.763 + 0.0017 \times VO) \times \left(1 + \frac{R1}{R2}\right)$$
 (2)

Table 3 lists the R1 values for some common output voltages. For higher output voltages of 1.8 V or above, a feedforward capacitor (C2) may be required to improve phase margin. Pads for this component (C2) are provided on the printed-circuit board. Note that the values given in Table 3 are standard values and not the exact value calculated using Table 3.

4 Test Setup and Results

This section describes how to properly connect, set up, and use the TPS54525EVM-608. The section also includes test results typical for the evaluation modules and efficiency, output load regulation, output line regulation, load transient response, output voltage ripple, input voltage ripple, start-up, and switching frequency.

4.1 Input/Output Connections

The TPS54525EVM-608 is provided with input/output connectors and test points as shown in Table 4. A power supply capable of supplying 2 A must be connected to J1 through a pair of 20 AWG wires. The load must be connected to J2 through a pair of 20 AWG wires. The maximum load current capability is 2 A. Wire lengths must be minimized to reduce losses in the wires. Test point TP1 provides a place to monitor the V_{IN} input voltages with TP2 providing a convenient ground reference. TP7 is used to monitor the output voltage with TP8 as the ground reference.

4.2 Start-Up Procedure

- 1. Ensure that the jumper at JP1 (Enable control) is set from EN to OFF.
- 2. Apply appropriate VIN voltage to VIN and PGND terminals at J1.
- 3. Move the jumper at JP1 (Enable control) to cover EN and ON. The EVM enables the output voltage.




Figure 1. TPS54525EVM-608 Efficiency

Figure 1 shows the efficiency for the TPS54525EVM-608 at an ambient temperature of 25°C.




Figure 2. TPS54525EVM-608 Light Load Efficiency

Figure 2 shows the efficiency at light loads for the TPS54525EVM-608 at an ambient temperature of 25°C.




Figure 3. TPS54525EVM-608 Load Regulation




Figure 4. TPS54525EVM-608 Line Regulation




Figure 5. TPS54525EVM-608 Load Transient Response

The TPS54525EVM-608 response to load transient is shown in Figure 5. The current step is from 1.25 A to 3.75 A. Total peak-to-peak voltage variation is as shown.




Figure 6. TPS54525EVM-608 Output Voltage Ripple

The TPS54525EVM-608 output voltage ripple is shown in Figure 6. The output current is the rated full load of 5.5 A.




Figure 7. TPS54525EVM-608 Input Voltage Ripple

The TPS54525EVM-608 input voltage ripple is shown in Figure 7. The output current is the rated full load of 5.5 A.




Figure 8. TPS54525EVM-608 Start-Up Relative to V_{IN}




Figure 9. TPS54525EVM-608 Start-Up Relative to EN

5 Board Layout

This section provides description of the TPS54525EVM-608, board layout, and layer illustrations.

5.1 Layout




Figure 10. Top Assembly

The board layout for the TPS54525EVM-608 is shown in Figure 10 through Figure 15. The top layer contains the main power traces for VIN, VO, and ground. Also on the top layer are connections for the pins of the TPS54525 and a large area filled with ground. Many of the signal traces also are located on the top side. The input decoupling capacitors are located as close to the IC as possible. The input and output connectors, test points, and most of the components are located on the top side. R3, the 0- Ω resistor that connects VIN to VCC and R4, the power good pull up, are located on the back side. Analog ground and power ground are connected at a single point on the top layer near pin 5 of the TPS54525. The internal layer 1 is a split plane containing analog and power grounds. The internal layer 2 is primarily power ground but also has a fill area of VIN and a trace routing VCC to the enable control jumper JP1. The bottom layer is primarily analog ground but also has traces to connect VIN to VCC through R3, traces for the power good signal, and the feedback trace from VOUT to the voltage setpoint divider network.




Figure 11. Top Layer




Figure 12. Internal Layer 1




Figure 13. Internal Layer 2




Figure 14. Bottom Layer




Figure 15. Bottom Assembly




Figure 16. TPS54525EVM-608 Schematic Diagram
