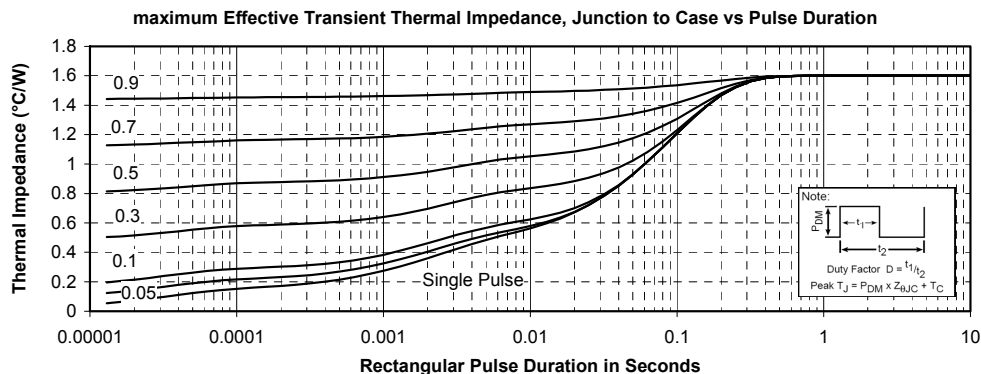
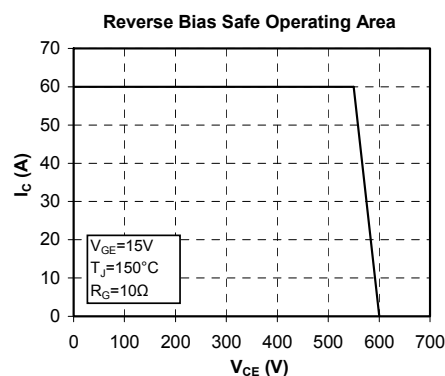
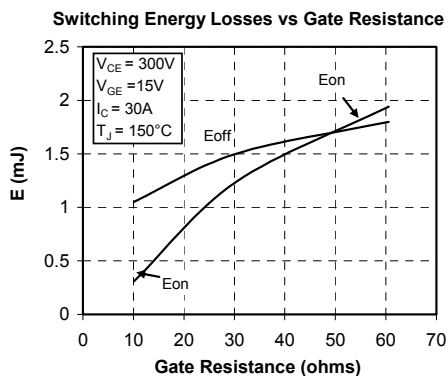
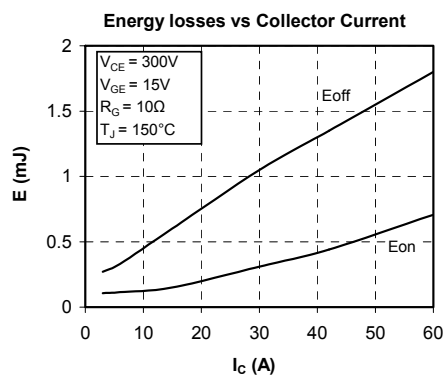
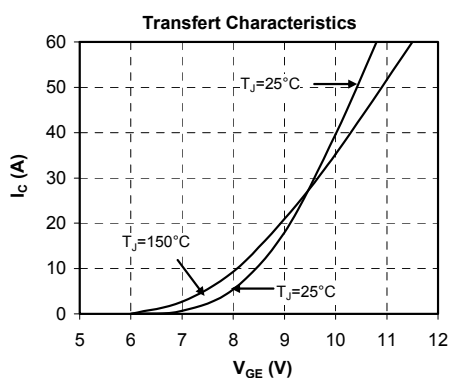
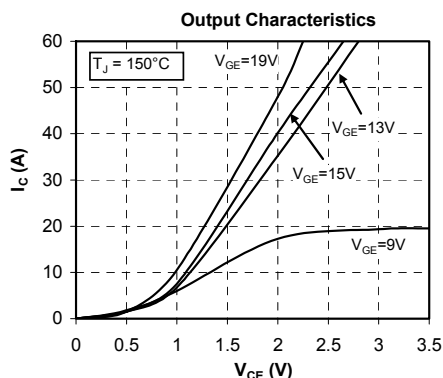
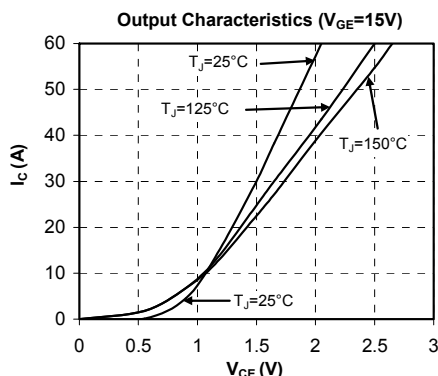
SP1 Package outline (dimensions in mm)



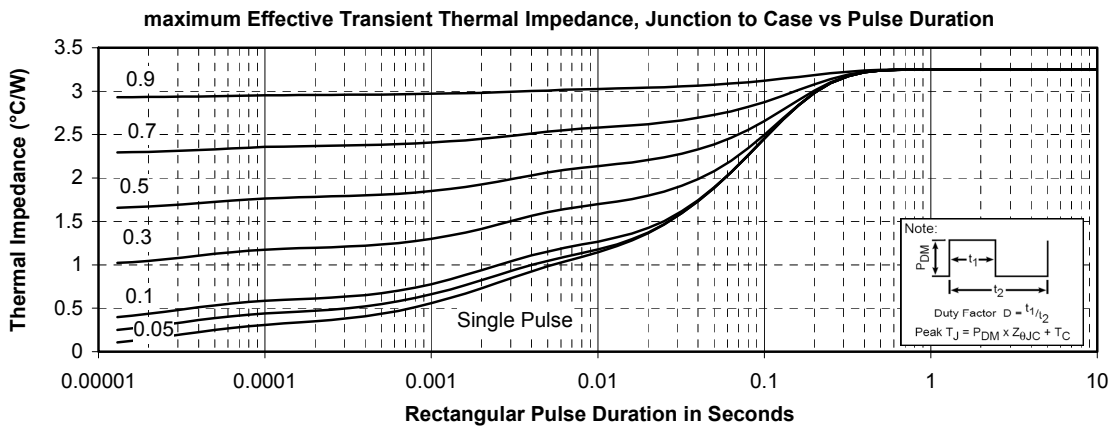
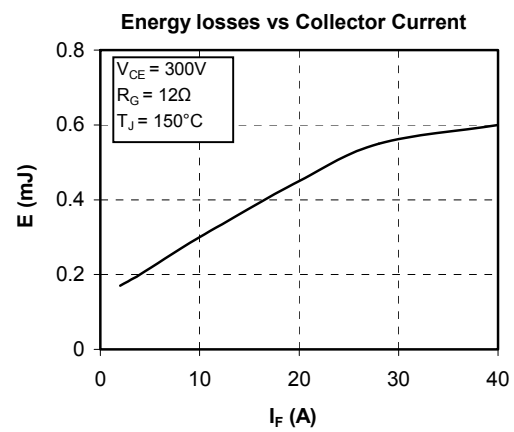
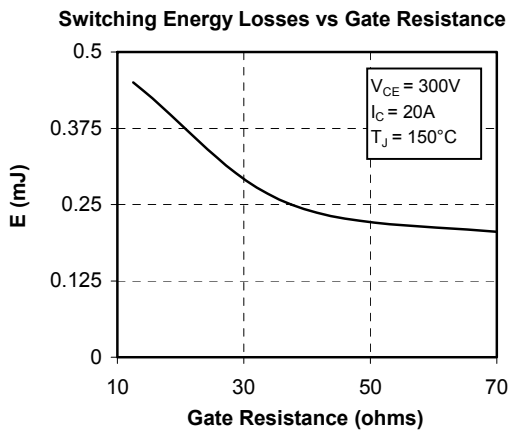
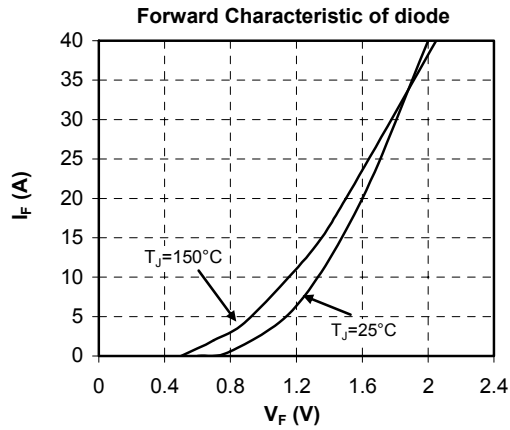

Q1 to Q4 Typical performance curve

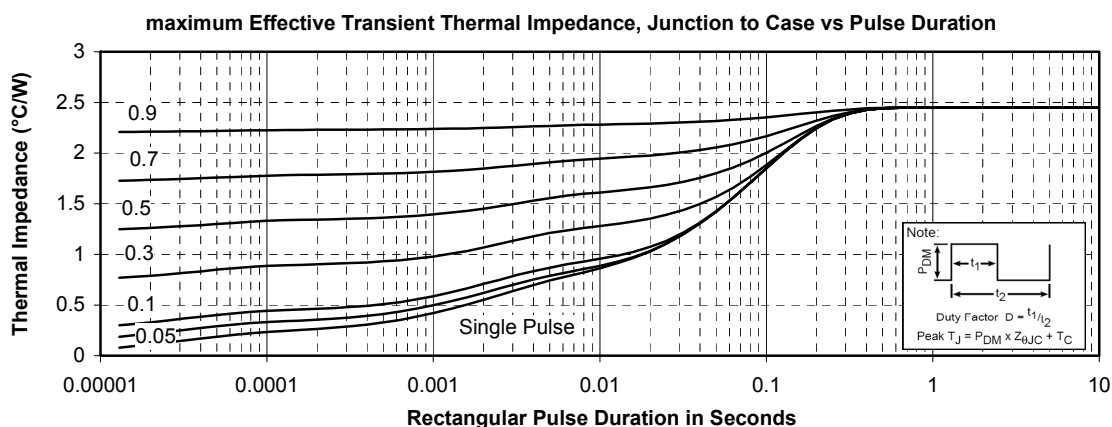
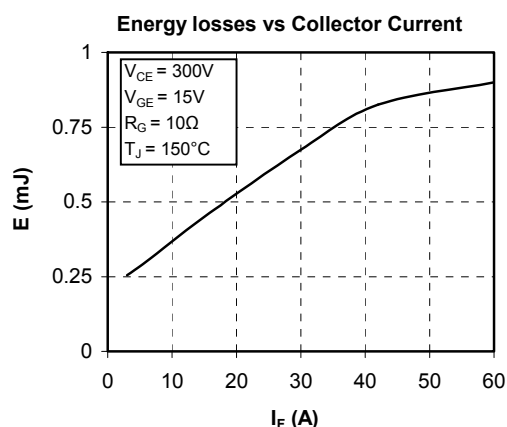
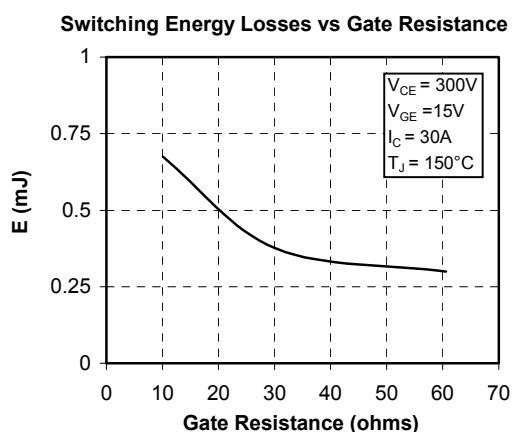
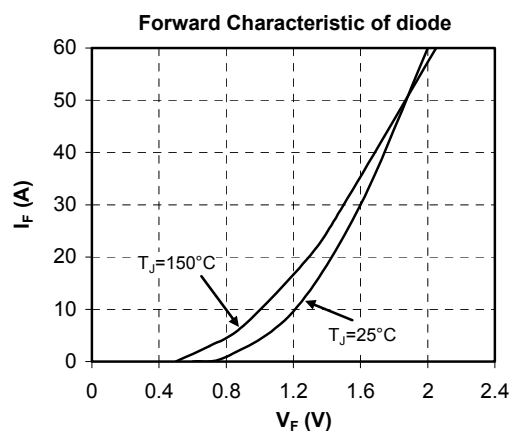




CR1 to CR4 Typical performance curve
