Thailand was hit by a devastating flood that impacted the production of Atmel's assembly subcontractor Chinteik Electronic Industries Co., Ltd. (CEI). Due to the continued serious flooding the production at the CEI facilities is disrupted for an indefinite period of time.								
This uncertainty has resulted in the need to transfer the assembly activities of the dual output flasher IC U2044B to ASE Shanghai.								
This transfer was announced in an ACN dated November 30, 2011. The package qualification is completed now.
