Description and Extent of Change:


25mils leadframe thickness for existing 5mm Lamp (for above part numbers) will be replaced by 18 mils leadframe thickness. There is no change in device functionality and electrical performance.

Reasons for Change:

Leadframe supplier had ceased operation and discontinued the supply of 25mils leadframe.



Effect of Change on Fit, Form, Function, Quality, or Reliability:



No impact to product performance as the only difference is in the leadframe thickness. This 18mils leadframe is an existing leadframe that is being used in production for other 5mm lamp part numbers.

Qualification and characterization have been conducted to confirm both existing 25mils and 18mils leadframes are comparable.

Effective Date of Change:

Avago Technologies will begin to ship these part numbers with 18mils leadframe effective from 1st Apr 2014 onwards.

All the qualification vehicles submitted to reliability tests passed Avago's reliability tests requirements. Qualification data would be available upon request.
