### **Summary**

The bump vendor 'C' of the selected product has made an announcement to discontinue the leaded bump line for these products. PMC is consequently in the process of moving the bump location to another bump vendor 'M'. In order to align with the RoHS requirements, PMC has also decided to convert the lead-containing bumps currently used on these products to Pb-free bumps, in anticipation of the exemption termination for the leaded bumps in FCBGA products. The external solder ball types will not change. The RoHS 6/6 compliant component will also be available upon request.

In order to help customers on the transition, PMC-Sierra will accept last-time buy orders for parts with the leaded bump until September 4, 2015, with last-time deliveries until March 18, 2016. All new orders for parts using the leaded bump shall be non-cancellable, and non-returnable (NCNR).
