ON Semiconductor announced on February 3, 2020 its intent to explore the sale of its manufacturing facility in Oudenaarde, Belgium. To ease the transition in a mutually beneficial manner, ON Semiconductor wishes to collect from its customers their product "All-time-needs" as early as possible to either timely plan the transition of its replacement part to another factory or to plan enough capacity within the current facility for building the Last-Time-Buy volume for products that will not be transferred to another factory.

ON Semiconductor wishes to promptly inform its customer of its intent to exit this small portion of its overall portfolio so that its customers may plan appropriately and effectively for replacement devices.
